ROAD TRAFFIC

The A76 Trunk Road (Hillhead Road, Mauchline to Glendale Cottage, Mauchline) (Temporary Prohibition of Traffic) Order 2010

Coming into force

29th June 2010

The Scottish Ministers make the following Order in exercise of the powers conferred by section 14(1) and (4), 2(1) and (2) and 4(1) of the Road Traffic Regulation Act 1984(a) and all other powers enabling them to do so.

In accordance with Section 14(1)(a) of that Act they are satisfied that traffic on the lengths of road specified in the Schedule should be prohibited because works are being or are proposed to be executed on or near that length of road.

In accordance with Section 14(3) of that Act they are satisfied that there is an alternative route suitable for traffic which will be affected by this Order.

Citation, commencement and cessation

1. This Order may be cited as the A76 Trunk Road (Hillhead Road, Mauchline to Glendale Cottage, Mauchline) (Temporary Prohibition of Traffic) Order 2010, comes into force on 29th June 2010 and ceases to have effect at midnight on 30th November 2010.

Prohibition of use of vehicles

2. Subject to article 3 no person shall use, or permit the use of, any vehicle on the lengths of road specified in the Schedule, when such prohibition is identified as applying to any part or parts of those lengths of road by means of one or more of the traffic signs prescribed in Diagram 7010.1 and 7105 of the Traffic Signs Regulations 2002(b).

The functions of the Secretary of State were transferred to the Scottish Ministers by section 53 of the Scotland Act 1998 (c.46).

Exemption for emergency and works vehicles

3. This Order does not apply to a vehicle while being used in an emergency for fire brigade, coastguard, ambulance or police purposes or a vehicle being used for carrying out the works.

SCHEDULE

Article 2

The following lengths of the A76 Dumfries – Kilmarnock Trunk Road:

1. From its Junction with Burnside Road, Mauchline to Glendale Cottage, Mauchline, a distance of 1.1 kilometres or thereby.
2. From its Junction with Hillhead Road, Mauchline to its Junction with Loudoun Street, Mauchline, a distance of 1.4 kilometres or thereby.
3. From its Junction with Burnside Road, Mauchline to its Junction with Mansefield Road, Mauchline, a distance of 310 metres or thereby.
