

CHAPTER xx.

An Act to confirm a Scheme of the Charity A.D. 1932.

Commissioners and of the Board of Education
for the application or management of the charity or foundation called Epsom College at Epsom in the County of Surrey.

[16th June 1932.]

WHEREAS the Charity Commissioners in their report to His Majesty of their proceedings during the year one thousand nine hundred and thirty-one reported that they had approved and certified a Scheme for the application or management of the charity or foundation called Epsom College at Epsom in the county of Surrey and further reported that the said Scheme had also been sealed by the Board of Education as the educational part of the said college was not within the jurisdiction of the said Commissioners:

And whereas the Board of Education in their report to His Majesty of their proceedings during the same year under sections fifty-four to sixty of the Charitable Trusts Act 1853 reported that they had approved and certified the same Scheme:

And whereas it is expedient that the Scheme as the same is fully set out and defined in the schedule to this Act should be confirmed:

Be it therefore enacted by the King's most Excellent Majesty by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present

- A.D. 1932. Parliament assembled and by the authority of the same as follows:—

Confirmation of Scheme. 1. The said Scheme is hereby confirmed Provided always that nothing in this Act or in the said Scheme shall be held to interfere with the ordinary jurisdiction over endowed charities now exerciseable or hereafter to become exerciseable by the High Court of Justice the Charity Commissioners and the Board of Education.

Short title.

2. This Act may be cited as the Epsom College Scheme Confirmation Act 1932.

SCHEDULE.

A.D. 1932.

Scheme for the application or management of the Charity or Foundation called Epsom College formerly the Royal Medical Benevolent College at Epsom in the County of Surrey regulated by the Act of Parliament 18 & 19 Vict. c. clxvi and the Royal Medical Benevolent College Act 1894.

- 1. In this Scheme the expression "the College" shall mean the above-mentioned Epsom College the expression "the Act of 1855" shall mean the Act of Parliament 18 & 19 Vict. c. clxvi intituled an Act to incorporate the Royal Medical Benevolent College and for other purposes and the expression "the Act of 1894" shall mean the Royal Medical Benevolent College Act 1894.
- 2. In the operative part of the Act of 1855 and in the operative part of the Act of 1894 the expression "duly qualified medical men" shall include women as well as men such women being qualified as prescribed by section thirty-seven of the Act of 1855 Provided that the widower of any woman who is a duly qualified medical man within the meaning of the said Acts shall not be eligible to receive any benefits which the widow of a duly qualified medical man within the meaning of the said Acts is eligible to receive.
- 3. The provisions of the Act of 1855 requiring the pensioners and foundation scholars of the College to be elected at a general meeting of the Governors of the College shall cease to have effect and henceforth the pensioners and foundation scholars of the College and also the recipients of annuities or occasional pecuniary assistance from the College shall be elected by the Council of the College or by a committee appointed by the Council The provisions of the Act of 1855 relating to committees appointed by the Council shall apply to any committee appointed under this clause except that not more than one half of the members of any such committee need be members of the Council.
- 4. The Acts of 1855 and 1894 shall be amended so far as is necessary to give effect to the provisions hereinbefore contained.


