GENERAL PROVISIONS AS TO MEMBERS AND PROCEEDINGS OF LOCAL AUTHORITIES

Meetings and proceedings

100 Admission of public and press to local authority committee meetings.

- (1) [F1The Public Bodies (Admission to Meetings) Act 1960 ("the 1960 Act") has effect in relation to meetings of committees of local authorities, subject to subsection (2).]
- (2) Without prejudice to section 2(1) of the 1960 Act (application of section 1 of that Act to any committee of a body whose membership consists of or includes all members of that body) section 1 of the 1960 Act shall apply F2... to any committee appointed by one or more local authorities under section 102 below, not being a committee falling within section 2(1) of the 1960 Act [F3 or section 100E(3)(a) or (b) below (whether or not by virtue of section 100J below)].
- (3) [F4Where section 1 of the 1960 Act applies to a committee by virtue of subsection (2) above, then, for the purposes of subsection (4)(c) of that section, premises belonging to the local authority or one or more of the local authorities which appointed the committee shall be treated as belonging to the committee.]
