### **4 Extension of power to regulate conduct of fishing operations, etc.**

- (2) In section 5 of the <sup>M1</sup>Sea Fisheries Act 1968 (regulation of conduct of fishing operations) in subsection (1) for the words “for the purpose of giving effect to any convention for the time being in force between Her Majesty’s Government in the United Kingdom and the government of any other country” there are inserted the words “whenever it appears to them necessary or expedient”.
- (2) In subsection (2) of that section, in paragraph (a) (British fishing boats) for the words “anywhere within the convention area to which the order relates” there are substituted the words “wherever they may be”.
- (3) In subsection (2) of that section, in paragraph (b) (foreign fishing boats) for the words “waters which are within both the fishery limits of the British Islands and that convention area” there are substituted the words “waters within British fishery limits”.
- (4) At the end of section 10 of the <sup>M2</sup> Sea Fisheries (Scotland) Amendment Act 1885 (powers of sea fishery officers) there are added the words “and section 10 of that Act shall apply for the purposes of this Act as if for any reference to section 8 or 9 of that Act there were substituted a reference to this section.”.
