1980 CHAPTER 16

An Act to make provision in connection with the attainment by the New Hebrides of independence within the Commonwealth. [20th March 1980]

2 Consequential amendments and repeals.

- (1) The provisions specified in Schedule 1 to this Act shall have effect subject to the amendments there specified, being amendments consequential on the attainment of independence within the Commonwealth by the New Hebrides.
- (2) The enactments and instruments mentioned in Schedule 2 to this Act are hereby repealed to the extent specified in column 3 of that Schedule.
