MISCELLANEOUS AND GENERAL

[^{F1}70A Service of notices.

- (1) Subject to subsection (2), [^{F2}section 329 of the ^{M1}Town and Country Planning Act 1990]] and [^{F3}section 271 of the Town and Country Planning (Scotland) Act 1997] (which provide for the service of notices and other documents) shall apply to notices and other documents required or authorised to be served or given under this Act.
- (2) [^{F4}Subsections (2) and (3) of the said section 329] shall not apply to a notice required to be served under paragraph 2 of Schedule 14.
- [^{F5}(2A) Subsection (1)(cc) of the said section 271 shall not apply to a notice required to be served under section 14G.
- (2B) Subsection (2) of the said section 271 shall not apply to a notice required to be served under section 14D(5)(a).]
- (3) This section shall not affect the operation of paragraph 2(4) of Schedule 11 or paragraph 3(4) of Schedule 15.
