## 1982 CHAPTER 52

### PART V

#### GENERAL

#### 18 Interpretation.

(1) In this Act “development area”<sup>F1</sup> ... and “intermediate area” mean an area for the time being specified or designated by an order made, or having effect as if made, under section 1 above, as the case may be, as a development area<sup>F1</sup> ... or as an intermediate area.

#### 19 Consequential provisions etc. and repeals.

(1) Schedule 2 to this Act (which contains amendments consequential on the provisions of this Act, transitional provisions and savings) shall have effect; and the provisions of that Schedule are without prejudice to sections 16 and 17 of the <sup>M1</sup>Interpretation Act 1978 (which relate to repeals).

(2) Subject to the provisions of Schedule 2 to this Act, the enactments and instruments specified in Schedule 3 to this Act are hereby repealed or, as the case may be, revoked to the extent specified in the third column of Schedule 3.

## 20 Short title, commencement and extent.

- (1) This Act may be cited as the Industrial Development Act 1982.
- (2) This Act shall come into force on the expiration of the period of three months beginning with its passing.
- (3) This Act extends to England and Wales and, except for section 14, to Scotland; but only the following provisions of this Act extend to Northern Ireland, that is to say, Part III, sections 11<sup>[F3]</sup>, 12 and 13A], and this section and (so far as they relate to enactments which extend to Northern Ireland) sections 15<sup>[F4]</sup>, 16] and 19 and Schedules 2 and 3.
