### PART V

#### THE RIGHT TO BUY

*Power to extend right to buy, etc.*

#### **171 Power to extend right to buy, etc.**

- (1) The Secretary of State may by order provide that, where there are in a dwelling-house let on a secure tenancy one or more interest to which this section applies, this Part and Part IV (secure tenancies) have effect with such modifications as are specified in the order.
- (2) This section applies to an interest held by—
  - a local authority,
  - a new town corporation,
  - [<sup>F1</sup>a housing action trust]
  - an urban development corporation,
  - [<sup>F2</sup>a Mayoral development corporation, ]
  - <sup>F3</sup> . . .
  - the [<sup>F4</sup>[<sup>F5</sup>Regulator of Social Housing] or Scottish Homes], [<sup>F6</sup>a non-profit registered provider of social housing] or
  - a [<sup>F7</sup>registered social landlord],which is immediately superior to the interest of the landlord or to another interest to which this section applies.
- (3) An order under this section—
  - (a) may make different provision with respect to different cases or descriptions of case;
  - (b) may contain such consequential, supplementary or transitional provisions as appear to the Secretary of State to be necessary or expedient; and

- (c) shall be made by statutory instrument which shall be subject to annulment in pursuance of a resolution of either House of Parliament.
