NON-DOMESTIC RATING ACCOUNTS

The accounts

- 1 (1) In accordance with this Schedule the [^{F1}Welsh Ministers] shall keep for each chargeable financial year an account (to be called a non-domestic rating account).
- (2) The [^{F2}Welsh Ministers]—
- (a) shall keep each account in such form [^{F3}as they consider appropriate], and
 - (b) shall at such time [^{F4}as they consider appropriate] send copies of each account to the [^{F5}Auditor General for Wales].

- ^{F7}(4) The Auditor General for Wales shall examine, certify and report on any account of which copies are sent to him under sub-paragraph (2) and shall lay copies of the account and of his report before the [^{F8}National Assembly for Wales].]
