RIGHTS OF COPYRIGHT OWNER

The acts restricted by copyright

18 Infringement by issue of copies to the public.

- (1) The issue to the public of copies of the work is an act restricted by the copyright in every description of copyright work.
- [F1[F2(2)] References in this Part to the issue to the public of copies of a work are to the act of putting into circulation in the United Kingdom copies not previously put into circulation in [F3the United Kingdom or] the EEA by or with the consent of the copyright owner.]
 - (3) References in this Part to the issue to the public of copies of a work do not include—
 - (a) any subsequent distribution, sale, hiring or loan of copies previously put into circulation (but see section 18A: infringement by rental or lending) ^{F4}...
 - ^{F7}[(4) References in this Part to the issue of copies of a work include the issue of the original.]
