#### ORDERS WITH RESPECT TO CHILDREN IN FAMILY PROCEEDINGS

#### General

# 12 [F1Child arrangements] orders and parental responsibility.

## [F2(1) Where—

- (a) the court makes a child arrangements order with respect to a child,
- (b) the father of the child, or a woman who is a parent of the child by virtue of section 43 of the Human Fertilisation and Embryology Act 2008, is named in the order as a person with whom the child is to live, and
- (c) the father, or the woman, would not otherwise have parental responsibility for the child,

the court must also make an order under section 4 giving the father, or under section 4ZA giving the woman, that responsibility.

## (1A) Where—

- (a) the court makes a child arrangements order with respect to a child,
- (b) the father of the child, or a woman who is a parent of the child by virtue of section 43 of the Human Fertilisation and Embryology Act 2008, is named in the order as a person with whom the child is to spend time or otherwise have contact but is not named in the order as a person with whom the child is to live, and
- (c) the father, or the woman, would not otherwise have parental responsibility for the child,

the court must decide whether it would be appropriate, in view of the provision made in the order with respect to the father or the woman, for him or her to have parental responsibility for the child and, if it decides that it would be appropriate for the father Changes to legislation: Children Act 1989, Section 12 is up to date with all changes known to be in force on or before 18 April 2024. - or the woman to have that responsibility, must also make an order under section 4 giving him, or under section 4ZA giving her, that responsibility.]
- (2) Where the court makes a [F3child arrangements order and a person who is not a] parent or guardian of the child concerned [F4 is named in the order as a person with whom the child is to live, ]that person shall have parental responsibility for the child while the [F5 order remains in force so far as providing for the child to live with that person].
- [F6(2A) Where the court makes a child arrangements order and—
  - (a) a person who is not the parent or guardian of the child concerned is named in the order as a person with whom the child is to spend time or otherwise have contact, but
  - (b) the person is not named in the order as a person with whom the child is to live, the court may provide in the order for the person to have parental responsibility for the child while paragraphs (a) and (b) continue to be met in the person's case.]
  - (3) Where a person has parental responsibility for a child as a result of subsection (2) [<sup>F7</sup>or (2A)], he shall not have the right—
    - (a) F8.....
    - (b) to agree, or refuse to agree, to the making of an adoption order, or an order under [<sup>F9</sup>section 84 of the Adoption and Children Act 2002], with respect to the child; or
    - (c) to appoint a guardian for the child.
  - (4) Where subsection (1) <sup>F10</sup>... requires the court to make an order under section 4 [F11] or 4ZA][F12] in respect of all [F13] parent] of a child, the court shall not bring that order to an end at any time while the [F14] child arrangements order concerned remains in force so far as providing for the child to live with that parent].
