### CONSEQUENTIAL PROVISIONS RELATING TO PAKISTAN

#### *Commonwealth Institute*

- 1 In section 8(2) of the <sup>M1</sup>Imperial Institute Act 1925, as amended by the <sup>M2</sup>Commonwealth Institute Act 1958 (power to vary the provisions of the said Act of 1925 if an agreement for the purpose is made with the governments of certain territories which for the time being are contributing to the expenses of the Commonwealth Institute) after “India,” there shall be inserted “Pakistan,”.

#### *Imperial War Museum*

- 2 (1) In the Schedule to the <sup>M3</sup>Imperial War Museum Act 1920 in paragraph (1) for the words “nineteen other members” there shall be substituted the words “twenty other members” and in the first and second columns of the Table in that paragraph after the entries relating to the Government of India there shall be inserted “1” and “the Government of Pakistan” respectively.
- (2) The above amendments are without prejudice to the power to vary the said paragraph (1) conferred by section 1 of the <sup>M4</sup>Imperial War Museum Act 1955.

#### *The Services*

- 3 In the definition of “Commonwealth force” in section 225(1) of the <sup>M5</sup>Army Act 1955 and section 223(1) of the <sup>M6</sup>Air Force Act 1955 and in the definition of “Commonwealth country” in section 135(1) of the <sup>M7</sup>Naval Discipline Act 1957 after “India,” there shall be inserted “Pakistan,”.

### *Visiting forces*

- 4 In the <sup>M8</sup>Visiting Forces (British Commonwealth) Act 1933 section 4 (attachment of personnel and mutual powers of command) shall apply in relation to forces raised in Pakistan as it applies to forces raised in Dominions within the meaning of the <sup>M9</sup>Statute of Westminster 1931.

- 5 In the <sup>M10</sup>Visiting Forces Act 1952, in section 1(1)(a) (countries to which the Act applies) after “India,” there shall be inserted “Pakistan, ”; and any Order in Council under section 8 of that Act for the time being in force (applying to visiting forces the law relating to home forces) shall be deemed to apply to the visiting forces of Pakistan until express provision with respect to that country is made under that section.

- 8 The operation of the <sup>M14</sup>Reciprocal Enforcement of Judgments (Pakistan) Order 1958 shall not be affected by any change in the status of Pakistan since the making of that Order; and, for the purposes of any further Order in relation to Pakistan under Part I of the <sup>M15</sup>Foreign Judgments (Reciprocal Enforcement) Act 1933, section 7 of that Act and any Order in Council under that section (application of Part I to Her Majesty’s dominions outside the United Kingdom) shall have effect as if references
