#### ADMINISTRATION AND ENFORCEMENT

##### *Offences*

#### 34 Time limit for prosecutions.

No prosecution for an offence under this Act which is punishable under section 35(2) below shall be begun after the expiry of—

- (a) three years from the commission of the offence; or
- (b) one year from its discovery by the prosecutor,

whichever is the earlier.

### 35 Punishment of offences.

- (1) A person guilty of an offence under section 33(1) above shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale or to imprisonment for a term not exceeding three months or to both.
- (2) A person guilty of any other offence under this Act shall be liable—
  - (a) on conviction on indictment, to a fine or to imprisonment for a term not exceeding two years or to both;
  - (b) on summary conviction, to a fine not exceeding the relevant amount or to imprisonment for a term not exceeding six months or to both.
- (3) In subsection (2) above “the relevant amount” means—
  - (a) in the case of an offence under <sup>F1</sup>section 7 or 14] above, £20,000;
  - (b) in any other case, the statutory maximum.
- (4) If a person who is—
  - (a) licensed under section 1 of the <sup>M1</sup>Slaughterhouses Act 1974 to keep a <sup>F2</sup>. . . knacker’s yard;
  - <sup>F3</sup>(b) . . . . .
  - (c) licensed under section 6 of <sup>F4</sup>the Slaughter of Animals (Scotland) Act 1980 to use any premises as a knacker’s yard,
 is convicted of an offence under Part II of this Act, the court may, in addition to any other punishment, cancel his licence or registration.
