##### *Offences*

#### 34 Time limit for prosecutions.

No prosecution for an offence under this Act which is punishable under <sup>[F1]</sup>section 35(2) [<sup>[F1]</sup> section 35(A1), (A2) or (2) ] below shall be begun after the expiry of—

- (a) three years from the commission of the offence; or
  - (b) one year from its discovery by the prosecutor,
- whichever is the earlier.

### 35 Punishment of offences.

[<sup>F2</sup>(A1) A person guilty of an offence under section 15B(5) above shall be liable on summary conviction to a fine not exceeding level 4 on the standard scale.

(A2) A person guilty of an offence under section 15C(2) or 15D(3) above shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.]

(1) A person guilty of an offence under section 33(1) above shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale or to imprisonment for a term not exceeding three months or to both.

[<sup>F3</sup>(1A) A person guilty of an offence under section 33(2), in so far as it relates to section 15C(1) or 15D(2), shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.]

(2) A person guilty of any other offence under this Act shall be liable—

(a) on conviction on indictment, to a fine or to imprisonment for a term not exceeding two years or to both;

(b) on summary conviction, to [<sup>F4</sup>a fine not exceeding the relevant amount][<sup>F4</sup>a fine] or to imprisonment for a term not exceeding six months or to both.

(3) [<sup>F5</sup>In subsection (2) above “the relevant amount” means—

(a) in the case of an offence under [<sup>F6</sup>section 7 or 14] above, £20,000;

(b) in any other case, the statutory maximum.]

(4) If a person who is—

(a) licensed under section 1 of the <sup>M1</sup>Slaughterhouses Act 1974 to keep a <sup>F7</sup>. . . knacker’s yard;

<sup>F8</sup>(b) . . . . .

(c) licensed under section 6 of [<sup>F9</sup>the Slaughter of Animals (Scotland) Act 1980] to use any premises as a knacker’s yard,

is convicted of an offence under Part II of this Act, the court may, in addition to any other punishment, cancel his licence or registration.

### 36 Offences by bodies corporate.

- (1) Where an offence under this Act which has been committed by a body corporate is proved to have been committed with the consent or connivance of, or to be attributable to any neglect on the part of—
- (a) any director, manager, secretary or other similar officer of the body corporate; or
- (b) any person who was purporting to act in any such capacity,
