Offences

34 Time limit for prosecutions. **E+W+S**

No prosecution for an offence under this Act which is punishable under ^[F1]section 35(2)]^[F1] section 35(A1), (A2) or (2)] below shall be begun after the expiry of—

- (a) three years from the commission of the offence; or
 - (b) one year from its discovery by the prosecutor,
- whichever is the earlier.

35 Punishment of offences. **E+W+S**

[^{F2}(A1) A person guilty of an offence under section 15B(5) above shall be liable on summary conviction to a fine not exceeding level 4 on the standard scale.

(A2) A person guilty of an offence under section 15C(2) or 15D(3) above shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.]

(1) A person guilty of an offence under section 33(1) above shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale or to imprisonment for a term not exceeding three months or to both.

[^{F3}(1A) A person guilty of an offence under section 33(2), in so far as it relates to section 15C(1) or 15D(2), shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.]

(2) A person guilty of any other offence under this Act shall be liable—

- (a) on conviction on indictment, to a fine or to imprisonment for a term not exceeding two years or to both;
- (b) on summary conviction, to [^{F4}a fine not exceeding the relevant amount][^{F4}a fine] or to imprisonment for a term not exceeding six months or to both.

(3) [^{F5}In subsection (2) above “the relevant amount” means—

- (a) in the case of an offence under [^{F6}section 7 or 14] above, £20,000;
- (b) in any other case, the statutory maximum.]

(4) If a person who is—

(a) licensed under section 1 of the ^{M1}Slaughterhouses Act 1974 to keep a ^{F7} . . . knacker’s yard;

(c) licensed under section 6 of [^{F9}the Slaughter of Animals (Scotland) Act 1980] to use any premises as a knacker’s yard,

is convicted of an offence under Part II of this Act, the court may, in addition to any other punishment, cancel his licence or registration.
