## 1993 CHAPTER 46

### *Health Service [F<sup>1</sup>Commissioner]*

#### 1 [F<sup>1</sup>The Commissioner].

- (1) For the purpose of conducting investigations in accordance with this Act, there shall continue to be—
- (a) a Health Service Commissioner for England [F<sup>2</sup>and]
  - F<sup>3</sup>(b) .....
  - F<sup>4</sup>(c) .....
- (2) References in this Act to [F<sup>5</sup>the Commissioner] (or Health Service Commissioner) are, unless the context otherwise requires, to [F<sup>6</sup>the Health Service Commissioner for England].
- (3) Schedule 1 has effect with respect to the appointment and remuneration of, and other administrative matters relating to, the Health Service Commissioner F<sup>7</sup>....
