

# Pharmacists (Fitness to Practise) Act 1997

# **1997 CHAPTER 19**

An Act to make provision about finding registered pharmaceutical chemists unfit to practise due to ill health; and for connected purposes. [19th March 1997]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

## 2 Commencement.

- (1) Section 1 and the Schedule are to come into force on such day as the Secretary of State may by order made by statutory instrument appoint.
- (2) Different days may be appointed for different purposes.

#### **3** Short title and extent.

- (1) This Act may be cited as the Pharmacists (Fitness to Practise) Act 1997.
- (2) This Act (except paragraph 5 of the Schedule) does not extend to Northern Ireland.
