Supplementary

76 Extent.

- (1) Except as provided by subsections (2) and (3), this Act extends to Northern Ireland only.
- (2) Paragraph 8 of Schedule 3 extends throughout the United Kingdom.
- (3) The amendment or repeal by this Act of any provision of—
 - (a) the M1Police (Overseas Service) Act 1945;
 - (b) the M2Police (Scotland) Act 1967;
 - (c) the M3 House of Commons Disqualification Act 1975;
 - (d) the M4Northern Ireland Assembly Disqualification Act 1975;
 - (e) the M5Ministry of Defence Police Act 1987;
 - (f) the M6Official Secrets Act 1989;
 - (g) the M7Police Act 1996;
 - (h) the M8 Police Act 1997,

has the same extent as that provision.
