## 1999 CHAPTER 29

### PART I

#### THE GREATER LONDON AUTHORITY

##### *Vacancy in the office of Mayor*

#### 13.— Failure to attend meetings.

[<sup>F1</sup>(1)] If the Mayor fails on six consecutive occasions to attend meetings of the Assembly held pursuant to section 52(3) below, he shall cease to be the Mayor.

[<sup>F2</sup>(2) Any meeting of the Assembly which the Mayor is unable to attend because he is suspended or partially suspended under section 66, <sup>F3</sup>[<sup>F4</sup>... 73, 78 <sup>F3</sup>... ] or 79 of the Local Government Act 2000 [<sup>F5</sup>, or suspended under section 31(4) of the Elections Act 2022,] shall be disregarded for the purposes of subsection (1) above.]
