

Regulation of Investigatory Powers Act 2000

2000 CHAPTER 23

U.K.

An Act to make provision for and about the interception of communications, the acquisition and disclosure of data relating to communications, the carrying out of surveillance, the use of covert human intelligence sources and the acquisition of the means by which electronic data protected by encryption or passwords may be decrypted or accessed; to provide for Commissioners and a tribunal with functions and jurisdiction in relation to those matters, to entries on and interferences with property or with wireless telegraphy and to the carrying out of their functions by the Security Service, the Secret Intelligence Service and the Government Communications Headquarters; and for connected purposes. [28th July 2000]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

CHAPTER I U.K.

INTERCEPTION

Unlawful and authorised interception

1 Unlawful interception. U.K.

- (1) It shall be an offence for a person intentionally and without lawful authority to intercept, at any place in the United Kingdom, any communication in the course of its transmission by means of—
 - (a) a public postal service; or
 - (b) a public telecommunication system.
- [FI(1A) The Interception of Communications Commissioner may serve a monetary penalty notice on a person if the Commissioner—
 - (a) considers that the person—
 - (i) i)has without lawful authority intercepted, at any place in the United Kingdom, any communication in the course of its transmission by means of a public telecommunication system, and
 - (ii) was not, at the time of the interception, making an attempt to act in accordance with an interception warrant which might, in the opinion of the Commissioner, explain the interception concerned, and
 - (b) does not consider that the person has committed an offence under subsection (1).
 - (1B) Schedule A1 (which makes further provision about monetary penalty notices) has effect.]
 - (2) It shall be an offence for a person—
 - (a) intentionally and without lawful authority, and
 - (b) otherwise than in circumstances in which his conduct is excluded by subsection (6) from criminal liability under this subsection,

to intercept, at any place in the United Kingdom, any communication in the course of its transmission by means of a private telecommunication system.

- (3) Any interception of a communication which is carried out at any place in the United Kingdom by, or with the express or implied consent of, a person having the right to control the operation or the use of a private telecommunication system shall be actionable at the suit or instance of the sender or recipient, or intended recipient, of the communication if it is without lawful authority and is either—
 - (a) an interception of that communication in the course of its transmission by means of that private system; or
 - (b) an interception of that communication in the course of its transmission, by means of a public telecommunication system, to or from apparatus comprised in that private telecommunication system.

- (4) Where the United Kingdom is a party to an international agreement which—
 - (a) relates to the provision of mutual assistance in connection with, or in the form of, the interception of communications,
 - (b) requires the issue of a warrant, order or equivalent instrument in cases in which assistance is given, and
 - (c) is designated for the purposes of this subsection by an order made by the Secretary of State,

it shall be the duty of the Secretary of State to secure that no request for assistance in accordance with the agreement is made on behalf of a person in the United Kingdom to the competent authorities of a country or territory outside the United Kingdom except with lawful authority.

- (5) Conduct has lawful authority for the purposes of this section if, and only if—
 - (a) it is authorised by or under section 3 or 4;
 - (b) it takes place in accordance with a warrant under section 5 ("an interception warrant"); or
 - (c) it is in exercise, in relation to any stored communication, of any statutory power that is exercised (apart from this section) for the purpose of obtaining information or of taking possession of any document or other property;

and conduct (whether or not prohibited by this section) which has lawful authority for the purposes of this section by virtue of paragraph (a) or (b) shall also be taken to be lawful for all other purposes.

- (6) The circumstances in which a person makes an interception of a communication in the course of its transmission by means of a private telecommunication system are such that his conduct is excluded from criminal liability under subsection (2) if—
 - (a) he is a person with a right to control the operation or the use of the system; or
 - (b) he has the express or implied consent of such a person to make the interception.
- (7) A person who is guilty of an offence under subsection (1) or (2) shall be liable—
 - (a) on conviction on indictment, to imprisonment for a term not exceeding two years or to a fine, or to both;
 - (b) on summary conviction, to a fine not exceeding the statutory maximum.
- (8) No proceedings for any offence which is an offence by virtue of this section shall be instituted—
 - (a) in England and Wales, except by or with the consent of the Director of Public Prosecutions;
 - (b) in Northern Ireland, except by or with the consent of the Director of Public Prosecutions for Northern Ireland.

2 Meaning and location of "interception" etc. U.K.

(1) In this Act—

"postal service" means any service which-

- (a) consists in the following, or in any one or more of them, namely, the collection, sorting, conveyance, distribution and delivery (whether in the United Kingdom or elsewhere) of postal items; and
- (b) is offered or provided as a service the main purpose of which, or one of the main purposes of which, is to make available, or to facilitate, a means of transmission from place to place of postal items containing communications;

"private telecommunication system" means any telecommunication system which, without itself being a public telecommunication system, is a system in relation to which the following conditions are satisfied—

- (a) it is attached, directly or indirectly and whether or not for the purposes of the communication in question, to a public telecommunication system; and
- (b) there is apparatus comprised in the system which is both located in the United Kingdom and used (with or without other apparatus) for making the attachment to the public telecommunication system;

"public postal service" means any postal service which is offered or provided to, or to a substantial section of, the public in any one or more parts of the United Kingdom;

"public telecommunications service" means any telecommunications service which is offered or provided to, or to a substantial section of, the public in any one or more parts of the United Kingdom;

"public telecommunication system" means any such parts of a telecommunication system by means of which any public telecommunications service is provided as are located in the United Kingdom;

"telecommunications service" means any service that consists in the provision of access to, and of facilities for making use of, any telecommunication system (whether or not one provided by the person providing the service); and

"telecommunication system" means any system (including the apparatus comprised in it) which exists (whether wholly or partly in the United Kingdom or elsewhere) for the purpose of facilitating the transmission of communications by any means involving the use of electrical or electromagnetic energy.

- (2) For the purposes of this Act, but subject to the following provisions of this section, a person intercepts a communication in the course of its transmission by means of a telecommunication system if, and only if, he—
 - (a) so modifies or interferes with the system, or its operation,
 - (b) so monitors transmissions made by means of the system, or
 - (c) so monitors transmissions made by wireless telegraphy to or from apparatus comprised in the system,

as to make some or all of the contents of the communication available, while being transmitted, to a person other than the sender or intended recipient of the communication.

- (3) References in this Act to the interception of a communication do not include references to the interception of any communication broadcast for general reception.
- (4) For the purposes of this Act the interception of a communication takes place in the United Kingdom if, and only if, the modification, interference or monitoring or, in the case of a postal item, the interception is effected by conduct within the United Kingdom and the communication is either—
 - (a) intercepted in the course of its transmission by means of a public postal service or public telecommunication system; or
 - (b) intercepted in the course of its transmission by means of a private telecommunication system in a case in which the sender or intended recipient of the communication is in the United Kingdom.
- (5) References in this Act to the interception of a communication in the course of its transmission by means of a postal service or telecommunication system do not include references to—
 - (a) any conduct that takes place in relation only to so much of the communication as consists in any traffic data comprised in or attached to a communication (whether by the sender or otherwise) for the purposes of any postal service or telecommunication system by means of which it is being or may be transmitted; or
 - (b) any such conduct, in connection with conduct falling within paragraph (a), as gives a person who is neither the sender nor the intended recipient only so much access to a communication as is necessary for the purpose of identifying traffic data so comprised or attached.
- (6) For the purposes of this section references to the modification of a telecommunication system include references to the attachment of any apparatus to, or other modification of or interference with—
 - (a) any part of the system; or
 - (b) any wireless telegraphy apparatus used for making transmissions to or from apparatus comprised in the system.
- (7) For the purposes of this section the times while a communication is being transmitted by means of a telecommunication system shall be taken to include any time when the system by means of which the communication is being, or has been, transmitted is used for storing it in a manner that enables the intended recipient to collect it or otherwise to have access to it.
- (8) For the purposes of this section the cases in which any contents of a communication are to be taken to be made available to a person while being transmitted shall include any case in which any of the contents of the communication, while being transmitted, are diverted or recorded so as to be available to a person subsequently.
- [F2(8A) For the purposes of the definition of "telecommunications service" in subsection (1), the cases in which a service is to be taken to consist in the provision of access to, and of facilities for making use of, a telecommunication system include any case where a service consists in or includes facilitating the creation, management or storage of communications transmitted, or that may be transmitted, by means of such a system.]
 - (9) In this section "traffic data", in relation to any communication, means—
 - (a) any data identifying, or purporting to identify, any person, apparatus or location to or from which the communication is or may be transmitted,

- (b) any data identifying or selecting, or purporting to identify or select, apparatus through which, or by means of which, the communication is or may be transmitted,
- (c) any data comprising signals for the actuation of apparatus used for the purposes of a telecommunication system for effecting (in whole or in part) the transmission of any communication, and
- (d) any data identifying the data or other data as data comprised in or attached to a particular communication,

but that expression includes data identifying a computer file or computer program access to which is obtained, or which is run, by means of the communication to the extent only that the file or program is identified by reference to the apparatus in which it is stored.

(10) In this section—

- (a) references, in relation to traffic data comprising signals for the actuation of apparatus, to a telecommunication system by means of which a communication is being or may be transmitted include references to any telecommunication system in which that apparatus is comprised; and
- (b) references to traffic data being attached to a communication include references to the data and the communication being logically associated with each other; and in this section "data", in relation to a postal item, means anything written on the outside of the item.
- (11) In this section "postal item" means any letter, postcard or other such thing in writing as may be used by the sender for imparting information to the recipient, or any packet or parcel.

3 Lawful interception without an interception warrant. U.K.

- (1) Conduct by any person consisting in the interception of a communication is authorised by this section if the communication is one which ^{F3}... is both—
 - (a) a communication sent by a person who has consented to the interception; and
 - (b) a communication the intended recipient of which has so consented.
- (2) Conduct by any person consisting in the interception of a communication is authorised by this section if—
 - (a) the communication is one sent by, or intended for, a person who has consented to the interception; and
 - (b) surveillance by means of that interception has been authorised under Part II.
- (3) Conduct consisting in the interception of a communication is authorised by this section if—
 - (a) it is conduct by or on behalf of a person who provides a postal service or a telecommunications service; and

- (b) it takes place for purposes connected with the provision or operation of that service or with the enforcement, in relation to that service, of any enactment relating to the use of postal services or telecommunications services.
- [F4(3A) Conduct consisting in the interception of a communication in the course of its transmission by means of a public postal service is authorised by this section if it is conduct—
 - (a) under section 159 of the Customs and Excise Management Act 1979 as applied by virtue of—
 - (i) section 105 of the Postal Services Act 2000 (power to open postal items etc.); or
 - (ii) that section 105 and another enactment; and
 - (b) by an officer of Revenue and Customs.]
- [F5(3B) Conduct consisting in the interception of a communication in the course of its transmission by means of a public postal service is authorised by this section if it is conduct under paragraph 9 of Schedule 7 to the Terrorism Act 2000 (port and border controls).]
 - (4) Conduct by any person consisting in the interception of a communication in the course of its transmission by means of wireless telegraphy is authorised by this section if it takes place—
 - (a) with the authority of a designated person under [F6 section 48 of the Wireless Telegraphy Act 2006 (interception and disclosure of wireless telegraphy messages)]; and
 - (b) for purposes connected with anything falling within subsection (5).
 - (5) Each of the following falls within this subsection—
 - [F7(a) the grant of wireless telegraphy licences under the Wireless Telegraphy Act 2006;]
 - (b) the prevention or detection of anything which constitutes interference with wireless telegraphy; and
 - (c) the enforcement of
 - [F8(i) any provision of Part 2 (other than Chapter 2 and sections 27 to 31) or Part 3 of that Act, or
 - (ii) any enactment not falling within sub-paragraph (i)] that relates to such interference.

4 Power to provide for lawful interception. U.K.

- (1) Conduct by any person ("the interceptor") consisting in the interception of a communication in the course of its transmission by means of a telecommunication system is authorised by this section if—
 - (a) the interception is carried out for the purpose of obtaining information about the communications of a person who, or who the interceptor has reasonable grounds for believing, is in a country or territory outside the United Kingdom;
 - (b) the interception relates to the use of a telecommunications service provided to persons in that country or territory which is either—
 - (i) a public telecommunications service; or
 - (ii) a telecommunications service that would be a public telecommunications service if the persons to whom it is offered or provided were members of the public in a part of the United Kingdom;
 - (c) the person who provides that service (whether the interceptor or another person) is required by the law of that country or territory to carry out, secure or facilitate the interception in question;
 - (d) the situation is one in relation to which such further conditions as may be prescribed by regulations made by the Secretary of State are required to be satisfied before conduct may be treated as authorised by virtue of this subsection; and
 - (e) the conditions so prescribed are satisfied in relation to that situation.
- (2) Subject to subsection (3), the Secretary of State may by regulations authorise any such conduct described in the regulations as appears to him to constitute a legitimate practice reasonably required for the purpose, in connection with the carrying on of any business, of monitoring or keeping a record of—
 - (a) communications by means of which transactions are entered into in the course of that business; or
 - (b) other communications relating to that business or taking place in the course of its being carried on.
- (3) Nothing in any regulations under subsection (2) shall authorise the interception of any communication except in the course of its transmission using apparatus or services provided by or to the person carrying on the business for use wholly or partly in connection with that business.
- (4) Conduct taking place in a prison is authorised by this section if it is conduct in exercise of any power conferred by or under any rules made under section 47 of the MI Prison Act 1952, section 39 of the MI Prison (Scotland) Act 1989 or section 13 of the MI Prison Act (Northern Ireland) 1953 (prison rules).
- (5) Conduct taking place in any hospital premises where high security psychiatric services are provided is authorised by this section if it is conduct in pursuance of, and in accordance with, any direction given under [F9[F10] section 4(3A)(a) of the National Health Service Act 2006], or section 19 or 23 of the National Health Service (Wales) Act 2006] (directions as to the carrying out of their functions by health bodies) to the body providing those services at those premises.
- (6) Conduct taking place in a state hospital is authorised by this section if it is conduct in pursuance of, and in accordance with, any direction given to the State Hospitals Board for Scotland under section 2(5) of the M4National Health Service (Scotland) Act 1978 (regulations and directions as to the exercise of their functions by health

- (7) In this section references to a business include references to any activities of a government department, of any public authority or of any person or office holder on whom functions are conferred by or under any enactment.
- (8) In this section—

"government department" includes any part of the Scottish Administration, a Northern Ireland department and [F11the Welsh Assembly Government];

"high security psychiatric services" has the same meaning as in [F12 section 4 of the National Health Service Act 2006];

"hospital premises" has the same meaning as in section 4(3) of that Act; and "state hospital" has the same meaning as in the M6National Health Service (Scotland) Act 1978.

- (9) In this section "prison" means—
 - (a) any prison, young offender institution, young offenders centre or remand centre which is under the general superintendence of, or is provided by, the Secretary of State under the M7Prison Act 1952 or the M8Prison Act (Northern Ireland) 1953, or
 - (b) any prison, young offenders institution or remand centre which is under the general superintendence of the Scottish Ministers under the M9Prisons (Scotland) Act 1989,

and includes any contracted out prison, within the meaning of Part IV of the MIOCriminal Justice Act 1991 or section 106(4) of the MIOCriminal Justice and Public Order Act 1994, and any legalised police cells within the meaning of section 14 of the MIOCRIMINATION (Scotland) Act 1989.

5 Interception with a warrant. U.K.

- (1) Subject to the following provisions of this Chapter, the Secretary of State may issue a warrant authorising or requiring the person to whom it is addressed, by any such conduct as may be described in the warrant, to secure any one or more of the following—
 - (a) the interception in the course of their transmission by means of a postal service or telecommunication system of the communications described in the warrant;
 - (b) the making, in accordance with an international mutual assistance agreement, of a request for the provision of such assistance in connection with, or in the form of, an interception of communications as may be so described;
 - (c) the provision, in accordance with an international mutual assistance agreement, to the competent authorities of a country or territory outside the United Kingdom of any such assistance in connection with, or in the form of, an interception of communications as may be so described;
 - (d) the disclosure, in such manner as may be so described, of intercepted material obtained by any interception authorised or required by the warrant, and of related communications data.
- (2) The Secretary of State shall not issue an interception warrant unless he believes—
 - (a) that the warrant is necessary on grounds falling within subsection (3); and
 - (b) that the conduct authorised by the warrant is proportionate to what is sought to be achieved by that conduct.
- (3) Subject to the following provisions of this section, a warrant is necessary on grounds falling within this subsection if it is necessary—
 - (a) in the interests of national security;
 - (b) for the purpose of preventing or detecting serious crime;
 - (c) for the purpose [F13, in circumstances appearing to the Secretary of State to be relevant to the interests of national security,] of safeguarding the economic well-being of the United Kingdom; or
 - (d) for the purpose, in circumstances appearing to the Secretary of State to be equivalent to those in which he would issue a warrant by virtue of paragraph (b), of giving effect to the provisions of any international mutual assistance agreement.
- (4) The matters to be taken into account in considering whether the requirements of subsection (2) are satisfied in the case of any warrant shall include whether the information which it is thought necessary to obtain under the warrant could reasonably be obtained by other means.
- (5) A warrant shall not be considered necessary on the ground falling within subsection (3) (c) unless the information which it is thought necessary to obtain is information relating to the acts or intentions of persons outside the British Islands.
- (6) The conduct authorised by an interception warrant shall be taken to include—

- (a) all such conduct (including the interception of communications not identified by the warrant) as it is necessary to undertake in order to do what is expressly authorised or required by the warrant;
- (b) conduct for obtaining related communications data; and
- (c) conduct by any person which is conduct in pursuance of a requirement imposed by or on behalf of the person to whom the warrant is addressed to be provided with assistance with giving effect to the warrant.

Interception warrants

8 Contents of warrants. U.K.

- (1) An interception warrant must name or describe either—
 - (a) one person as the interception subject; or
 - (b) a single set of premises as the premises in relation to which the interception to which the warrant relates is to take place.
- (2) The provisions of an interception warrant describing communications the interception of which is authorised or required by the warrant must comprise one or more schedules setting out the addresses, numbers, apparatus or other factors, or combination of factors, that are to be used for identifying the communications that may be or are to be intercepted.
- (3) Any factor or combination of factors set out in accordance with subsection (2) must be one that identifies communications which are likely to be or to include—

- (a) communications from, or intended for, the person named or described in the warrant in accordance with subsection (1); or
- (b) communications originating on, or intended for transmission to, the premises so named or described.
- (4) Subsections (1) and (2) shall not apply to an interception warrant if—
 - (a) the description of communications to which the warrant relates confines the conduct authorised or required by the warrant to conduct falling within subsection (5); and
 - (b) at the time of the issue of the warrant, a certificate applicable to the warrant has been issued by the Secretary of State certifying—
 - (i) the descriptions of intercepted material the examination of which he considers necessary; and
 - (ii) that he considers the examination of material of those descriptions necessary as mentioned in section 5(3)(a), (b) or (c).

9 Duration, cancellation and renewal of warrants. U.K.

10 Modification of warrants and certificates. U.K.

- (1) The Secretary of State may at any time—
 - (a) modify the provisions of an interception warrant; or
 - (b) modify a section 8(4) certificate so as to include in the certified material any material the examination of which he considers to be necessary as mentioned in section 5(3)(a), (b) or (c).
- (2) If at any time the Secretary of State considers that any factor set out in a schedule to an interception warrant is no longer relevant for identifying communications which, in the case of that warrant, are likely to be or to include communications falling within section 8(3)(a) or (b), it shall be his duty to modify the warrant by the deletion of that factor.
- (3) If at any time the Secretary of State considers that the material certified by a section 8(4) certificate includes any material the examination of which is no longer necessary as mentioned in any of paragraphs (a) to (c) of section 5(3), he shall modify the certificate so as to exclude that material from the certified material.
- (4) Subject to subsections (5) to (8), a warrant or certificate shall not be modified under this section except by an instrument under the hand of the Secretary of State or of a senior official.

- (8) Where modifications in accordance with this subsection are expressly authorised by provision contained in the warrant, the scheduled parts of an interception warrant may, in an urgent case, be modified by an instrument under the hand of—
 - (a) the person to whom the warrant is addressed; or
 - (b) a person holding any such position subordinate to that person as may be identified in the provisions of the warrant.

(9) Where—

- (a) a warrant or certificate is modified by an instrument under the hand of a person other than the Secretary of State [F28 or, as the case may be, the Scottish Ministers (by virtue of provision made under section 63 of the Scotland Act 1998)], and
- (b) a statement for the purposes of subsection (5)(b) [F29, (5A)(b)][F30, (6)] or (7)(b) is endorsed on the instrument, or the modification is made under subsection (8),

that modification shall cease to have effect at the end of the fifth working day following the day of the instrument's issue.

- (10) For the purposes of this section—
 - (a) the scheduled parts of an interception warrant are any provisions of the warrant that are contained in a schedule of identifying factors comprised in the warrant for the purposes of section 8(2); and

11 Implementation of warrants. U.K.

- (1) Effect may be given to an interception warrant either—
 - (a) by the person to whom it is addressed; or
 - (b) by that person acting through, or together with, such other persons as he may require (whether under subsection (2) or otherwise) to provide him with assistance with giving effect to the warrant.
- (2) For the purpose of requiring any person to provide assistance in relation to an interception warrant the person to whom it is addressed may—
 - (a) serve a copy of the warrant on such persons as he considers may be able to provide such assistance; or
 - (b) make arrangements under which a copy of it is to be or may be so served.
- [F31(2A) A copy of a warrant may be served under subsection (2) on a person outside the United Kingdom (and may relate to conduct outside the United Kingdom).
 - (2B) Service under subsection (2) of a copy of a warrant on a person outside the United Kingdom may (in addition to electronic or other means of service) be effected in any of the following ways—
 - (a) by serving it at the person's principal office within the United Kingdom or, if the person has no such office in the United Kingdom, at any place in the United Kingdom where the person carries on business or conducts activities;
 - (b) if the person has specified an address in the United Kingdom as one at which the person, or someone on the person's behalf, will accept service of documents of the same description as a copy of a warrant, by serving it at that address;

- (c) by making it available for inspection (whether to the person or to someone acting on the person's behalf) at a place in the United Kingdom (but this is subject to subsection (2C)).
- (2C) Service under subsection (2) of a copy of a warrant on a person outside the United Kingdom may be effected in the way mentioned in paragraph (c) of subsection (2B) only if—
 - (a) it is not reasonably practicable for service to be effected by any other means (whether as mentioned in subsection (2B)(a) or (b) or otherwise), and
 - (b) the person to whom the warrant is addressed takes such steps as the person thinks appropriate for the purpose of bringing the contents of the warrant, and the availability of a copy for inspection, to the attention of the person outside the United Kingdom.

The steps mentioned in paragraph (b) must be taken as soon as reasonably practicable after the copy of the warrant is made available for inspection.]

- (3) The copy of an interception warrant that is served on any person under subsection (2) may, to the extent authorised—
 - (a) by the person to whom the warrant is addressed, or
 - (b) by the arrangements made by him for the purposes of that subsection, omit any one or more of the schedules to the warrant.
- (4) Where a copy of an interception warrant has been served by or on behalf of the person to whom it is addressed on—
 - (a) a person who provides a postal service,
 - (b) a person who provides a public telecommunications service, or
 - (c) a person not falling within paragraph (b) who has control of the whole or any part of a telecommunication system located wholly or partly in the United Kingdom,

it shall (subject to subsection (5)) be the duty of that person [F32] (whether or not the person is in the United Kingdom)] to take all such steps for giving effect to the warrant as are notified to him by or on behalf of the person to whom the warrant is addressed.

- (5) A person who is under a duty by virtue of subsection (4) to take steps for giving effect to a warrant shall not be required to take any steps which it is not reasonably practicable for him to take.
- [F33(5A)] Where a person outside the United Kingdom is under a duty by virtue of subsection (4) to take any steps in a country or territory outside the United Kingdom for giving effect to a warrant, in determining for the purposes of subsection (5) whether the steps are reasonably practicable for the person to take, regard is to be had (amongst other matters) to—
 - (a) any requirements or restrictions under the law of that country or territory relevant to the taking of those steps, and
 - (b) the extent to which it is reasonably practicable to give effect to the warrant in a way that does not breach any such requirements or restrictions.]
 - (6) For the purposes of subsection (5) the steps which it is reasonably practicable for a person to take in a case in which obligations have been imposed on him by or under section 12 shall include every step which it would have been reasonably practicable for him to take had he complied with all the obligations so imposed on him.

- (7) A person who knowingly fails to comply with his duty under subsection (4) shall be guilty of an offence and liable—
 - (a) on conviction on indictment, to imprisonment for a term not exceeding two years or to a fine, or to both;
 - (b) on summary conviction, to imprisonment for a term not exceeding six months or to a fine not exceeding the statutory maximum, or to both.

Interception capability and costs

12 Maintenance of interception capability. U.K.

- (1) The Secretary of State may by order provide for the imposition by him on persons who—
 - (a) are providing public postal services or public telecommunications services, or
 - (b) are proposing to do so,
 - of such obligations as it appears to him reasonable to impose for the purpose of securing that it is and remains practicable for requirements to provide assistance in relation to interception warrants to be imposed and complied with.
- (2) The Secretary of State's power to impose the obligations provided for by an order under this section shall be exercisable by the giving, in accordance with the order, of a notice requiring the person who is to be subject to the obligations to take all such steps as may be specified or described in the notice.

13 Technical Advisory Board. U.K.

- (1) There shall be a Technical Advisory Board consisting of such number of persons appointed by the Secretary of State as he may by order provide.
- (2) The order providing for the membership of the Technical Advisory Board must also make provision which is calculated to ensure—

Extra safeguards in the case of certificated warrants. U.K.

- (1) For the purposes of section 15 the requirements of this section, in the case of a warrant in relation to which there is a section 8(4) certificate, are that the intercepted material is read, looked at or listened to by the persons to whom it becomes available by virtue of the warrant to the extent only that it—
 - (a) has been certified as material the examination of which is necessary as mentioned in section 5(3)(a), (b) or (c); and
 - (b) falls within subsection (2).
- (2) Subject to subsections (3) and (4), intercepted material falls within this subsection so far only as it is selected to be read, looked at or listened to otherwise than according to a factor which—

19 Offence for unauthorised disclosures. U.K.

- (1) Where an interception warrant has been issued or renewed, it shall be the duty of every person falling within subsection (2) to keep secret all the matters mentioned in subsection (3).
- (2) The persons falling within this subsection are—
 - (a) the persons specified in section 6(2);
 - (b) every person holding office under the Crown;
 - F78(c)
 - (e) every person employed by or for the purposes of a police force;
 - (f) persons providing postal services or employed for the purposes of any business of providing such a service;
 - (g) persons providing public telecommunications services or employed for the purposes of any business of providing such a service;
 - (h) persons having control of the whole or any part of a telecommunication system located wholly or partly in the United Kingdom.
- (3) Those matters are—
 - (a) the existence and contents of the warrant and of any section 8(4) certificate in relation to the warrant:
 - (b) the details of the issue of the warrant and of any renewal or modification of the warrant or of any such certificate;
 - (c) the existence and contents of any requirement to provide assistance with giving effect to the warrant;
 - (d) the steps taken in pursuance of the warrant or of any such requirement; and

Interpretation of Chapter I

20 Interpretation of Chapter I. U.K.

In this Chapter—

"certified", in relation to a section 8(4) certificate, means of a description certified by the certificate as a description of material the examination of which the Secretary of State considers necessary;

"external communication" means a communication sent or received outside the British Islands:

"intercepted material", in relation to an interception warrant, means the contents of any communications intercepted by an interception to which the warrant relates;

21 Lawful acquisition and disclosure of communications data. U.K.

- (1) This Chapter applies to—
 - (a) any conduct in relation to a postal service or telecommunication system for obtaining communications data, other than conduct consisting in the interception of communications in the course of their transmission by means of such a service or system; and
 - (b) the disclosure to any person of communications data.

but that expression includes data identifying a computer file or computer program access to which is obtained, or which is run, by means of the communication to the extent only that the file or program is identified by reference to the apparatus in which it is stored.

(7) In this section—

- references, in relation to traffic data comprising signals for the actuation of apparatus, to a telecommunication system by means of which a communication is being or may be transmitted include references to any telecommunication system in which that apparatus is comprised; and
- references to traffic data being attached to a communication include references to the data and the communication being logically associated with each other; and in this section "data", in relation to a postal item, means anything written on the outside of the item.

Obtaining and disclosing communications data. U.K.

- (1) This section applies where a person designated for the purposes of this Chapter believes that it is necessary on grounds falling within subsection (2) to obtain any communications data.

Introductory

Conduct to which Part II applies. U.K.

- (1) This Part applies to the following conduct—
 - (a) directed surveillance;
 - (b) intrusive surveillance; and
 - (c) the conduct and use of covert human intelligence sources.
- (2) Subject to subsection (6), surveillance is directed for the purposes of this Part if it is covert but not intrusive and is undertaken—
 - (a) for the purposes of a specific investigation or a specific operation:
 - (b) in such a manner as is likely to result in the obtaining of private information about a person (whether or not one specifically identified for the purposes of the investigation or operation); and
 - (c) otherwise than by way of an immediate response to events or circumstances the nature of which is such that it would not be reasonably practicable for

an authorisation under this Part to be sought for the carrying out of the surveillance.

- (3) Subject to subsections (4) to (6), surveillance is intrusive for the purposes of this Part if, and only if, it is covert surveillance that—
 - (a) is carried out in relation to anything taking place on any residential premises or in any private vehicle; and
 - (b) involves the presence of an individual on the premises or in the vehicle or is carried out by means of a surveillance device.
- (4) For the purposes of this Part surveillance is not intrusive to the extent that—
 - (a) it is carried out by means only of a surveillance device designed or adapted principally for the purpose of providing information about the location of a vehicle; or
 - (b) it is surveillance consisting in any such interception of a communication as falls within section 48(4).
- (5) For the purposes of this Part surveillance which—
 - (a) is carried out by means of a surveillance device in relation to anything taking place on any residential premises or in any private vehicle, but
 - (b) is carried out without that device being present on the premises or in the vehicle,

is not intrusive unless the device is such that it consistently provides information of the same quality and detail as might be expected to be obtained from a device actually present on the premises or in the vehicle.

- (6) For the purposes of this Part surveillance which—
 - (a) is carried out by means of apparatus designed or adapted for the purpose of detecting the installation or use in any residential or other premises of a television receiver (within the meaning of [F109]Part 4 of the Communications Act 2003)], and
 - (b) is carried out from outside those premises exclusively for that purpose, is neither directed nor intrusive.

(7) In this Part—

- (a) references to the conduct of a covert human intelligence source are references to any conduct of such a source which falls within any of paragraphs (a) to (c) of subsection (8), or is incidental to anything falling within any of those paragraphs; and
- (b) references to the use of a covert human intelligence source are references to inducing, asking or assisting a person to engage in the conduct of such a source, or to obtain information by means of the conduct of such a source.
- (8) For the purposes of this Part a person is a covert human intelligence source if—
 - (a) he establishes or maintains a personal or other relationship with a person for the covert purpose of facilitating the doing of anything falling within paragraph (b) or (c);
 - (b) he covertly uses such a relationship to obtain information or to provide access to any information to another person; or
 - (c) he covertly discloses information obtained by the use of such a relationship, or as a consequence of the existence of such a relationship.

Grant of authorisations in the senior officer's absence. U.K.

- (1) This section applies in the case of an application for an authorisation for the carrying out of intrusive surveillance where—

Notification of authorisations for intrusive surveillance. U.K.

- (1) Where a person grants or cancels a [F196 police, F197 the National Crime Agency], [F198 Revenue and Customs [F199, immigration]]][F200 or CMA] authorisation for the carrying out of intrusive surveillance, he shall give notice that he has done so to an ordinary Surveillance Commissioner.

Quashing of police and [F228 Revenue and Customs] authorisations etc. U.K.

- (1) This section applies where an authorisation for the carrying out of intrusive surveillance has been granted on the application of—
 - (a) a member of a police force;
 - [F229(b) a National Crime Agency officer;]
 - [F230(d) an officer of Revenue and Customs F231...;]
 - [F232(da) an immigration officer; or]
 - I^{F233}(e) an officer of the CMA.]
- (2) Where an ordinary Surveillance Commissioner is at any time satisfied that, at the time when the authorisation was granted or at any time when it was renewed, there were no reasonable grounds for believing that the requirements of section 32(2)(a) and (b) were satisfied, he may quash the authorisation with effect, as he thinks fit, from the time of the grant of the authorisation or from the time of any renewal of the authorisation.
- (3) If an ordinary Surveillance Commissioner is satisfied at any time while the authorisation is in force that there are no longer any reasonable grounds for believing that the requirements of section 32(2)(a) and (b) are satisfied in relation to the authorisation, he may cancel the authorisation with effect from such time as appears to him to be the time from which those requirements ceased to be so satisfied.
- (4) Where, in the case of any authorisation of which notice has been given in accordance with section 35(3)(b), an ordinary Surveillance Commissioner is at any time satisfied that, at the time of the grant or renewal of the authorisation to which that notice related, there were no reasonable grounds for believing that the case was one of urgency, he may quash the authorisation with effect, as he thinks fit, from the time of the grant of the authorisation or from the time of any renewal of the authorisatio
- (5) Subject to subsection (7), where an ordinary Surveillance Commissioner quashes an authorisation under this section, he may order the destruction of any records relating wholly or partly to information obtained by the authorised conduct after the time from which his decision takes effect.
- (6) Subject to subsection (7), where—
 - (a) an authorisation has ceased to have effect (otherwise than by virtue of subsection (2) or (4)), and
 - (b) an ordinary Surveillance Commissioner is satisfied that there was a time while the authorisation was in force when there were no reasonable grounds for believing that the requirements of section 32(2)(a) and (b) continued to be satisfied in relation to the authorisation,

he may order the destruction of any records relating, wholly or partly, to information obtained at such a time by the authorised conduct.

- (7) No order shall be made under this section for the destruction of any records required for pending criminal or civil proceedings.
- (8) Where an ordinary Surveillance Commissioner exercises a power conferred by this section, he shall, as soon as reasonably practicable, make a report of his exercise of that power, and of his reasons for doing so—
 - (a) to the most senior relevant person (within the meaning of section 36); and
 - (b) to the Chief Surveillance Commissioner.

- (9) Where an order for the destruction of records is made under this section, the order shall not become operative until such time (if any) as—
 - (a) the period for appealing against the decision to make the order has expired;

38 Appeals against decisions by Surveillance Commissioners. U.K.

- (1) Any senior authorising officer may appeal to the Chief Surveillance Commissioner against any of the following—

- (b) he is not satisfied that the authorisation is one of which notice was given in accordance with section 35(3)(b) without there being any reasonable grounds for believing that the case was one of urgency.

 - (a) is satisfied that grounds exist which justify the quashing or cancellation under section 37 of the authorisation in question, but
 - (b) considers that the authorisation should have been quashed or cancelled from a different time from that from which it was quashed or cancelled by the ordinary Surveillance Commissioner against whose decision the appeal is brought,

he may modify that Commissioner's decision to quash or cancel the authorisation, and any related decision for the destruction of records, so as to give effect to the decision under section 37 that he considers should have been made.

42 Intelligence services authorisations. U.K.

- (1) The grant by the Secretary of State [F240] or, the Scottish Ministers (by virtue of provision under section 63 of the Scotland Act 1998)] on the application of a member of one of the intelligence services of any authorisation under this Part must be made by the issue of a warrant.
- (2) A single warrant issued by the Secretary of State [F240] or, the Scottish Ministers (by virtue of provision under s. 63 of the Scotland Act 1998) may combine both—
 - (a) an authorisation under this Part; and
 - (b) an intelligence services warrant;

but the provisions of this Act or the M41Intelligence Services Act 1994 that are applicable in the case of the authorisation under this Part or the intelligence services warrant shall apply separately in relation to the part of the combined warrant to which they are applicable.

- (3) Intrusive surveillance in relation to any premises or vehicle in the British Islands shall be capable of being authorised by a warrant issued under this Part on the application of a member of the Secret Intelligence Service or GCHQ only if the authorisation contained in the warrant is one satisfying the requirements of section 32(2)(a) otherwise than in connection with any functions of that intelligence service in support of the prevention or detection of serious crime.
- (4) Subject to subsection (5), the functions of the Security Service shall include acting on behalf of the Secret Intelligence Service or GCHQ in relation to—
 - the application for and grant of any authorisation under this Part in connection with any matter within the functions of the Secret Intelligence Service or GCHQ; and

- (b) the carrying out, in connection with any such matter, of any conduct authorised by such an authorisation.
- (5) Nothing in subsection (4) shall authorise the doing of anything by one intelligence service on behalf of another unless—
 - (a) it is something which either the other service or a member of the other service has power to do; and
 - (b) it is done otherwise than in connection with functions of the other service in support of the prevention or detection of serious crime.
- (6) In this section "intelligence services warrant" means a warrant under section 5 of the M42Intelligence Services Act 1994.

- [F242(6A) The relevant judicial authority (within the meaning given by subsection (7) of section 32A) shall not make an order under that section approving the renewal of an authorisation for the conduct or the use of a covert human intelligence source unless the relevant judicial authority—

- (c) in the case of any grant or renewal that takes effect under subsection (2) of section [F24432A or] 36 at a time or on a day later than that given by paragraph (a) or (b), to the time at which or, as the case may be, day on which the grant or renewal takes effect in accordance with that subsection.

Power to require disclosure

49 Notices requiring disclosure. U.K.

- (1) This section applies where any protected information—
 - (a) has come into the possession of any person by means of the exercise of a statutory power to seize, detain, inspect, search or otherwise to interfere with documents or other property, or is likely to do so;
 - (b) has come into the possession of any person by means of the exercise of any statutory power to intercept communications, or is likely to do so;
 - (c) has come into the possession of any person by means of the exercise of any power conferred by an authorisation under section 22(3) [F264] or (3B)] or under Part II, or as a result of the giving of a notice under section 22(4), or is likely to do so;
 - (d) has come into the possession of any person as a result of having been provided or disclosed in pursuance of any statutory duty (whether or not one arising as a result of a request for information), or is likely to do so; or
 - (e) has, by any other lawful means not involving the exercise of statutory powers, come into the possession of any of the intelligence services, the police, [F265] the National Crime Agency]F266... or [F267] Her Majesty's Revenue and Customs], or is likely so to come into the possession of any of those services, the police, [F265] the National Crime Agency]F266... or [F267] Her Majesty's Revenue and Customs].
- (2) If any person with the appropriate permission under Schedule 2 believes, on reasonable grounds—
 - (a) that a key to the protected information is in the possession of any person,
 - (b) that the imposition of a disclosure requirement in respect of the protected information is—
 - (i) necessary on grounds falling within subsection (3), or

- (ii) necessary for the purpose of securing the effective exercise or proper performance by any public authority of any statutory power or statutory duty,
- (c) that the imposition of such a requirement is proportionate to what is sought to be achieved by its imposition, and
- (d) that it is not reasonably practicable for the person with the appropriate permission to obtain possession of the protected information in an intelligible form without the giving of a notice under this section,

the person with that permission may, by notice to the person whom he believes to have possession of the key, impose a disclosure requirement in respect of the protected information.

- (3) A disclosure requirement in respect of any protected information is necessary on grounds falling within this subsection if it is necessary—
 - (a) in the interests of national security;
 - (b) for the purpose of preventing or detecting crime; or
 - (c) in the interests of the economic well-being of the United Kingdom.
- (4) A notice under this section imposing a disclosure requirement in respect of any protected information—
 - (a) must be given in writing or (if not in writing) must be given in a manner that produces a record of its having been given;
 - (b) must describe the protected information to which the notice relates;
 - (c) must specify the matters falling within subsection (2)(b)(i) or (ii) by reference to which the notice is given;
 - (d) must specify the office, rank or position held by the person giving it;
 - (e) must specify the office, rank or position of the person who for the purposes of Schedule 2 granted permission for the giving of the notice or (if the person giving the notice was entitled to give it without another person's permission) must set out the circumstances in which that entitlement arose;
 - (f) must specify the time by which the notice is to be complied with; and
 - (g) must set out the disclosure that is required by the notice and the form and manner in which it is to be made;

and the time specified for the purposes of paragraph (f) must allow a period for compliance which is reasonable in all the circumstances.

- (5) Where it appears to a person with the appropriate permission—
 - (a) that more than one person is in possession of the key to any protected information,
 - (b) that any of those persons is in possession of that key in his capacity as an officer or employee of any body corporate, and
 - (c) that another of those persons is the body corporate itself or another officer or employee of the body corporate,

a notice under this section shall not be given, by reference to his possession of the key, to any officer or employee of the body corporate unless he is a senior officer of the body corporate or it appears to the person giving the notice that there is no senior officer of the body corporate and (in the case of an employee) no more senior employee of the body corporate to whom it is reasonably practicable to give the notice.

50 Effect of notice imposing disclosure requirement. U.K.

- (1) Subject to the following provisions of this section, the effect of a section 49 notice imposing a disclosure requirement in respect of any protected information on a person who is in possession at a relevant time of both the protected information and a means of obtaining access to the information and of disclosing it in an intelligible form is that he—
 - (a) shall be entitled to use any key in his possession to obtain access to the information or to put it into an intelligible form; and
 - (b) shall be required, in accordance with the notice imposing the requirement, to make a disclosure of the information in an intelligible form.
- (2) A person subject to a requirement under subsection (1)(b) to make a disclosure of any information in an intelligible form shall be taken to have complied with that requirement if—
 - (a) he makes, instead, a disclosure of any key to the protected information that is in his possession; and
 - (b) that disclosure is made, in accordance with the notice imposing the requirement, to the person to whom, and by the time by which, he was required to provide the information in that form.
- (3) Where, in a case in which a disclosure requirement in respect of any protected information is imposed on any person by a section 49 notice—
 - (a) that person is not in possession of the information,
 - (b) that person is incapable, without the use of a key that is not in his possession, of obtaining access to the information and of disclosing it in an intelligible form, or
 - (c) the notice states, in pursuance of a direction under section 51, that it can be complied with only by the disclosure of a key to the information,

the effect of imposing that disclosure requirement on that person is that he shall be required, in accordance with the notice imposing the requirement, to make a disclosure of any key to the protected information that is in his possession at a relevant time.

- (4) Subsections (5) to (7) apply where a person ("the person given notice")—
 - (a) is entitled or obliged to disclose a key to protected information for the purpose of complying with any disclosure requirement imposed by a section 49 notice; and
 - (b) is in possession of more than one key to that information.
- (5) It shall not be necessary, for the purpose of complying with the requirement, for the person given notice to make a disclosure of any keys in addition to those the disclosure of which is, alone, sufficient to enable the person to whom they are disclosed to obtain access to the information and to put it into an intelligible form.

- (7) Subject to subsections (5) and (6), the person given notice shall not be taken to have complied with the disclosure requirement by the disclosure of a key unless he has disclosed every key to the protected information that is in his possession at a relevant time.

- (1) A section 49 notice imposing a disclosure requirement in respect of any protected information shall not contain a statement for the purposes of section 50(3)(c) unless—

- (4) A person shall not give a direction for the purposes of subsection (1) unless he believes—
 - (a) that there are special circumstances of the case which mean that the purposes for which it was believed necessary to impose the requirement in question would be defeated, in whole or in part, if the direction were not given; and
 - (b) that the giving of the direction is proportionate to what is sought to be achieved by prohibiting any compliance with the requirement in question otherwise than by the disclosure of the key itself.

Contributions to costs

52 Arrangements for payments for disclosure. U.K.

- (1) It shall be the duty of the Secretary of State to ensure that such arrangements are in force as he thinks appropriate for requiring or authorising, in such cases as he thinks fit, the making to persons to whom section 49 notices are given of appropriate contributions towards the costs incurred by them in complying with such notices.
- (2) For the purpose of complying with his duty under this section, the Secretary of State may make arrangements for payments to be made out of money provided by Parliament.

Offences

Failure to comply with a notice. U.K.

- (1) A person to whom a section 49 notice has been given is guilty of an offence if he knowingly fails, in accordance with the notice, to make the disclosure required by virtue of the giving of the notice.
- (2) In proceedings against any person for an offence under this section, if it is shown that that person was in possession of a key to any protected information at any time before the time of the giving of the section 49 notice, that person shall be taken for the purposes of those proceedings to have continued to be in possession of that key at all subsequent times, unless it is shown that the key was not in his possession after the giving of the notice and before the time by which he was required to disclose it.
- (3) For the purposes of this section a person shall be taken to have shown that he was not in possession of a key to protected information at a particular time if—
 - (a) sufficient evidence of that fact is adduced to raise an issue with respect to it; and
 - (b) the contrary is not proved beyond a reasonable doubt.
- (4) In proceedings against any person for an offence under this section it shall be a defence for that person to show—
 - (a) that it was not reasonably practicable for him to make the disclosure required by virtue of the giving of the section 49 notice before the time by which he was required, in accordance with that notice, to make it; but
 - (b) that he did make that disclosure as soon after that time as it was reasonably practicable for him to do so.

54 Tipping-off. U.K.

- (1) This section applies where a section 49 notice contains a provision requiring—
 - (a) the person to whom the notice is given, and
 - (b) every other person who becomes aware of it or of its contents,

to keep secret the giving of the notice, its contents and the things done in pursuance of it.

- (2) A requirement to keep anything secret shall not be included in a section 49 notice except where—
 - (a) it is included with the consent of the person who for the purposes of Schedule 2 granted the permission for the giving of the notice; or
 - (b) the person who gives the notice is himself a person whose permission for the giving of such a notice in relation to the information in question would have constituted appropriate permission under that Schedule.
- (3) A section 49 notice shall not contain a requirement to keep anything secret except where the protected information to which it relates—
 - (a) has come into the possession of the police, [F287 the National Crime Agency], F288... [F289 Her Majesty's Revenue and Customs] or any of the intelligence services, or
 - (b) is likely to come into the possession of the police, [F287 the National Crime Agency], F288 ... [F289 Her Majesty's Revenue and Customs] or any of the intelligence services,

by means which it is reasonable, in order to maintain the effectiveness of any investigation or operation or of investigatory techniques generally, or in the interests of the safety or well-being of any person, to keep secret from a particular person.

(4) A person who makes a disclosure to any other person of anything that he is required by a section 49 notice to keep secret shall be guilty of an offence and liable—

- (a) on conviction on indictment, to imprisonment for a term not exceeding five years or to a fine, or to both;
- (b) on summary conviction, to imprisonment for a term not exceeding six months or to a fine not exceeding the statutory maximum, or to both.
- (5) In proceedings against any person for an offence under this section in respect of any disclosure, it shall be a defence for that person to show that—
 - (a) the disclosure was effected entirely by the operation of software designed to indicate when a key to protected information has ceased to be secure; and
 - (b) that person could not reasonably have been expected to take steps, after being given the notice or (as the case may be) becoming aware of it or of its contents, to prevent the disclosure.
- (6) In proceedings against any person for an offence under this section in respect of any disclosure, it shall be a defence for that person to show that—
 - (a) the disclosure was made by or to a professional legal adviser in connection with the giving, by the adviser to any client of his, of advice about the effect of provisions of this Part; and
 - (b) the person to whom or, as the case may be, by whom it was made was the client or a representative of the client.
- (7) In proceedings against any person for an offence under this section in respect of any disclosure, it shall be a defence for that person to show that the disclosure was made by a legal adviser—
 - (a) in contemplation of, or in connection with, any legal proceedings; and

 - (b) that the uses to which a key so disclosed is put are reasonable having regard both to the uses to which the person using the key is entitled to put any protected information to which it relates and to the other circumstances of the case;
 - (c) that, having regard to those matters, the use and any retention of the key are proportionate to what is sought to be achieved by its use or retention;
 - (d) that the requirements of subsection (3) are satisfied in relation to any key disclosed in pursuance of a section 49 notice;
 - (e) that, for the purpose of ensuring that those requirements are satisfied, any key so disclosed is stored, for so long as it is retained, in a secure manner;
 - (f) that all records of a key so disclosed (if not destroyed earlier) are destroyed as soon as the key is no longer needed for the purpose of enabling protected information to be put into an intelligible form.

- (3) The requirements of this subsection are satisfied in relation to any key disclosed in pursuance of a section 49 notice if—
 - (a) the number of persons to whom the key is disclosed or otherwise made available, and
 - (b) the number of copies made of the key,

are each limited to the minimum that is necessary for the purpose of enabling protected information to be put into an intelligible form.

and loss or damage shall be taken into account for the purposes of that subsection to the extent only that it relates to the disclosure of particular protected information or a particular key which, in the case of a person falling with paragraph (b), must be his information or key.

 - (a) information belongs to a person if he has any right that would be infringed by an unauthorised disclosure of the information; and
 - (b) a key belongs to a person if it is a key to information that belongs to him or he has any right that would be infringed by an unauthorised disclosure of the key.

61 Investigatory Powers Commissioner for Northern Ireland. U.K.

- (1) The Prime Minister, after consultation with the First Minister and deputy First Minister in Northern Ireland, shall appoint a Commissioner to be known as the Investigatory Powers Commissioner for Northern Ireland.

PROSPECTIVE

Orders allocating proceedings to the Tribunal. U.K.

71 Issue and revision of codes of practice. U.K.

(1) The Secretary of State shall issue one or more codes of practice relating to the exercise and performance of the powers and duties mentioned in subsection (2).

- (2) Those powers and duties are those (excluding any power to make subordinate legislation [F351] and subject to subsection (10)]) that are conferred or imposed otherwise than on the Surveillance Commissioners [F352] or the relevant judicial authority (within the meaning of section 23A or 32A)] by or under—
 - (a) Parts I to III of this Act;
 - (b) section 5 of the M63Intelligence Services Act 1994 (warrants for interference with property or wireless telegraphy for the purposes of the intelligence services); and

72 Effect of codes of practice. U.K.

PART 1 U.K.

MONETARY PENALTY NOTICES

General

- 1 (1) A monetary penalty notice is a notice requiring the person on whom it is served to pay to the Interception of Communications Commissioner ("the Commissioner") a monetary penalty of an amount determined by the Commissioner and specified in the notice.
 - (2) The amount determined by the Commissioner must not exceed £50,000.
 - (3) The monetary penalty must be paid to the Commissioner within such period as is specified in the notice.
 - (4) The period concerned must not be less than 28 days beginning with the day after the day on which the notice is served.
 - (5) The notice must, in particular—
 - (a) state the name and address of the person on whom it is to be served.
 - (b) provide details of the notice of intent served on that person,
 - (c) state whether the Commissioner has received written representations in accordance with that notice,
 - (d) state the grounds on which the Commissioner serves the monetary penalty notice,
 - (e) state the grounds on which the Commissioner decided the amount of the monetary penalty,
 - (f) state the details of how the monetary penalty is to be paid,
 - (g) provide details of the rights of appeal of the person concerned under paragraph 5 in respect of the monetary penalty notice,
 - (h) provide details of the Commissioner's rights of enforcement under paragraph 6 in respect of the monetary penalty notice.

(6) Any sum received by the Commissioner by virtue of a monetary penalty notice must be paid into the Consolidated Fund.

Enforcement obligations

- 2 (1) The Commissioner may include one or more than one enforcement obligation in a monetary penalty notice if the Commissioner considers that the interception to which the notice relates is continuing.
 - (2) Each of the following is an enforcement obligation—
 - (a) a requirement on the person on whom the notice is served to cease the interception concerned on such day, or within such period, as is specified in the notice,
 - (b) (where appropriate for achieving such a cessation) a requirement on the person to take within such period as is specified in the notice, or to refrain from taking after the end of such period as is so specified, such steps as are so specified.
 - (3) No enforcement obligation is to have effect before the end of the period of 7 days beginning with the day after the day on which the notice is served.
 - (4) Where an enforcement obligation is included in a monetary penalty notice under this paragraph, the notice must state what the obligation is and the grounds for including it.

Consultation requirements before service of notices

- 3 (1) The Commissioner must proceed in accordance with sub-paragraphs (2) to (7) before serving a monetary penalty notice on a person.
 - (2) The Commissioner must serve a notice of intent on the person.
 - (3) A notice of intent is a notice that the Commissioner proposes to serve a monetary penalty notice on the person.
 - (4) A notice of intent must, in particular—
 - (a) state the name and address of the person concerned,
 - (b) state the grounds on which the Commissioner proposes to serve the monetary penalty notice,
 - (c) provide an indication of the amount of the monetary penalty that the Commissioner proposes to impose and the Commissioner's grounds for deciding that amount,
 - (d) state whether the monetary penalty notice is to include any enforcement obligation and, if so, what the obligation is and the grounds for including it,
 - (e) state the date on which the Commissioner proposes to serve the monetary penalty notice,
 - (f) inform the person concerned that the person may make written representations in relation to the Commissioner's proposal within a period specified in the notice, and
 - (g) inform the person concerned that the person may, within a period specified in the notice, request an oral hearing before the Commissioner in order to make representations of the kind mentioned in sub-paragraph (6)(b).

- (6) Where the person concerned has requested an oral hearing within the period specified for the purpose in the notice—
 - (a) the Commissioner must arrange such a hearing, and
 - (b) the person may make representations at the hearing about—
 - (i) i)any matter falling within section 1(1A)(a)(ii), or
 - (ii) any other matter relating to the Commissioner's proposal which, by virtue of section 17, the person would be unable to raise on an appeal under paragraph 5.
- (7) The Commissioner must consider any representations which have been made by the person concerned in accordance with the notice or sub-paragraph (6).
- (8) Subject to sub-paragraph (9), the Commissioner may not vary a notice of intent.
- (9) The Commissioner may vary a notice of intent by extending the period mentioned in sub-paragraph (4)(f) or (g).
- (10) Sub-paragraph (8) does not prevent the Commissioner from issuing a new notice of intent instead of varying such a notice.
- (11) The Commissioner may cancel a notice of intent.
- (12) A variation or cancellation of a notice of intent is effected by serving on the person on whom the notice was served a notice setting out the variation or cancellation.
- (13) Subject to sub-paragraph (14), the Commissioner must not serve a monetary penalty notice on a person in respect of an interception if any notice of intent in respect of that interception was served on the person more than 3 months earlier.
- (14) The Commissioner may serve a monetary penalty notice on a person where the service of the notice would otherwise be prevented by virtue of sub-paragraph (13) if the Commissioner—
 - (a) considers it reasonable to do so, and
 - (b) includes the reasons for doing so in the monetary penalty notice.
- (15) If the Commissioner decides not to serve a monetary penalty notice on a person as a result of any representations which have been made by the person in accordance with a notice of intent or sub-paragraph (6), the Commissioner must inform the person of that fact.

Variation or cancellation of notices

- 4 (1) The Commissioner may, subject as follows, vary or cancel a monetary penalty notice.
 - (2) The Commissioner may not vary a monetary penalty notice in a way that is detrimental to the person on whom it was served (whether by increasing the amount of the monetary penalty, by reducing the period specified in the notice as the period within which the penalty must be paid, by imposing a new enforcement obligation or making an existing enforcement obligation effective earlier or otherwise more onerous, or otherwise).
 - (3) The Commissioner must—

- (4) A variation or cancellation of a monetary penalty notice is effected by serving on the person on whom the monetary penalty notice was served a notice setting out the variation or cancellation.
- (5) The Commissioner may not serve another monetary penalty notice on a person in respect of an interception if the Commissioner has cancelled a previous notice served on the person in respect of the same interception.
- (6) If the Commissioner refuses a request by a person to vary or cancel a monetary penalty notice which has been served on the person, the Commissioner must inform the person of that fact.

Appeals against notices

- 5 (1) A person on whom a monetary penalty notice is served may appeal to the First-tier Tribunal against—
 - (a) the monetary penalty notice or any provision of it, or
 - (b) any refusal of a request by the person to issue a notice of variation or cancellation in relation to the monetary penalty notice.
 - (2) Where there is an appeal under sub-paragraph (1)(a) in relation to a monetary penalty notice or any provision of it, any requirement in the notice or (as the case may be) provision concerned which does not relate to the imposition of an enforcement obligation need not be complied with until the appeal is withdrawn or finally determined.
 - (3) Sub-paragraphs (4) to (6) apply in relation to an appeal under sub-paragraph (1)(a).
 - (4) The First-tier Tribunal must allow the appeal or substitute such other monetary penalty notice as could have been served by the Commissioner if the Tribunal considers—
 - (a) that the notice concerned is not in accordance with the law, or
 - (b) to the extent that the notice involved an exercise of discretion by the Commissioner, that the Commissioner ought to have exercised the discretion differently.
 - (5) In any other case, the First-tier Tribunal must dismiss the appeal.
 - (6) The First-tier Tribunal may review any determination of fact on which the notice concerned was based.
 - (7) Sub-paragraphs (8) to (10) apply in relation to an appeal under sub-paragraph (1)(b).
 - (8) The First-tier Tribunal must direct the Commissioner to issue, on such terms as the Tribunal considers appropriate, a notice of variation or cancellation in relation to the monetary penalty notice if the Tribunal considers that the monetary penalty notice ought to be varied or cancelled on those terms.
 - (9) In any other case, the First-tier Tribunal must dismiss the appeal.

(10) The First-tier Tribunal may review any determination of fact on which the refusal to issue the notice of variation or cancellation was based.

Enforcement of notices

- 6 (1) Sub-paragraphs (2) and (3) apply in relation to any penalty payable to the Commissioner by virtue of a monetary penalty notice.
 - (2) In England and Wales or Northern Ireland, the penalty is recoverable—
 - (a) if [F387] the county court in England and Wales or a county court in Northern Ireland] so orders, as if it were payable under an order of that court,
 - (b) if the High Court so orders, as if it were payable under an order of that court.
 - (3) In Scotland, the penalty is recoverable as if it were payable under an extract registered decree arbitral bearing a warrant for execution issued by the sheriff for any sheriffdom in Scotland.
 - (4) The person on whom a monetary penalty notice containing an enforcement obligation is served must comply with the obligation; and that duty is enforceable by civil proceedings by the Commissioner for an injunction, or for specific performance of a statutory duty under section 45 of the Court of Session Act 1988 M83, or for any other appropriate relief.

 - (7) Sub-paragraphs (8) to (10) apply in relation to an appeal under sub-paragraph (1)(b).
 - (8) The First-tier Tribunal must direct the Commissioner to issue, on such terms as the Tribunal considers appropriate, a notice of variation or cancellation in relation to the information notice if the Tribunal considers that the information notice ought to be varied or cancelled on those terms.
 - (9) In any other case, the First-tier Tribunal must dismiss the appeal.

 - (b) knowingly or recklessly gives any information which is false in a material particular in response to an information notice.
 - (2) Subject to sub-paragraphs (3) to (7), Part 1 of this Schedule applies in relation to a Part 2 monetary penalty notice and the penalty that relates to that notice as it applies in relation to a Part 1 monetary penalty notice and the penalty that relates to that notice.
 - (3) The amount of the monetary penalty determined by the Commissioner and specified in the Part 2 monetary penalty notice may be—
 - (a) a fixed amount,
 - (b) an amount calculated by reference to a daily rate, or
 - (c) a fixed amount and an amount calculated by reference to a daily rate, provided that the total amount payable does not exceed £10,000.
 - (4) In the case of an amount calculated by reference to a daily rate—
 - (a) no account is to be taken of the day on which the Part 2 monetary penalty notice is served or any day before that day, and
 - (b) the Part 2 monetary penalty notice must specify—
 - (i) i)the day on which the amount first starts to accumulate and the circumstances in which it is to cease to accumulate, and
 - (ii) the period or periods within which the amount, or any part or parts so far accumulated, must be paid to the Commissioner (provided that no such period ends less than 28 days beginning with the day after the day on which the notice is served).
 - (5) The provisions in Part 1 of this Schedule so far as relating to enforcement obligations do not apply in relation to a Part 2 monetary penalty notice.
 - (6) Paragraph 3 applies by virtue of sub-paragraph (2) above as if—
 - (a) paragraph 3(6)(b)(i), the word "or" at the end of that sub-paragraph (i) and the word "other" in paragraph 3(6)(b)(ii) were omitted, and
 - (b) in paragraph 3(13) the references to an interception were references to conduct falling within paragraph 11(1)(a) or (b).

Section 49

PERSONS HAVING THE APPROPRIATE PERMISSION

Requirement that appropriate permission is granted by a judge

- 1 (1) Subject to the following provisions of this Schedule, a person has the appropriate permission in relation to any protected information if, and only if, written permission for the giving of section 49 notices in relation to that information has been granted—
 - (a) in England and Wales, by a Circuit judge;
 - (b) in Scotland, by a sheriff; or
 - (c) in Northern Ireland, by a county court judge.
 - (2) Nothing in paragraphs 2 to 5 of this Schedule providing for the manner in which a person may be granted the appropriate permission in relation to any protected information without a grant under this paragraph shall be construed as requiring any further permission to be obtained in a case in which permission has been granted under this paragraph.

Data obtained under warrant etc.

- 2 (1) This paragraph applies in the case of protected information falling within section 49(1)(a), (b) or (c) where the statutory power in question is one exercised, or to be exercised, in accordance with—
 - (a) a warrant issued by the Secretary of State or a person holding judicial office; or
 - (b) an authorisation under Part III of the M90 Police Act 1997 (authorisation of otherwise unlawful action in respect of property).
 - (2) Subject to sub-paragraphs (3) to (5) and paragraph 6(1), a person has the appropriate permission in relation to that protected information (without any grant of permission under paragraph 1) if—
 - (a) the warrant or, as the case may be, the authorisation contained the relevant authority's permission for the giving of section 49 notices in relation to protected information to be obtained under the warrant or authorisation; or
 - (b) since the issue of the warrant or authorisation, written permission has been granted by the relevant authority for the giving of such notices in relation to protected information obtained under the warrant or authorisation.

- (3) Only persons holding office under the Crown, the police [F454, F455] the National Crime Agency,]F456... and F457Her Majesty's Revenue and Customs] shall be capable of having the appropriate permission in relation to protected information obtained, or to be obtained, under a warrant issued by the Secretary of State.
- (4) Only a person who—
 - (a) was entitled to exercise the power conferred by the warrant, or
 - (b) is of the description of persons on whom the power conferred by the warrant was, or could have been, conferred,

shall be capable of having the appropriate permission in relation to protected information obtained, or to be obtained, under a warrant issued by a person holding judicial office.

- (5) Only the police [F458, F459] the National Crime Agency,]]F460... and [F457]Her Majesty's Revenue and Customs] shall be capable of having the appropriate permission in relation to protected information obtained, or to be obtained, under an authorisation under Part III of the M91Police Act 1997.
- (6) In this paragraph "the relevant authority"—
 - (a) in relation to a warrant issued by the Secretary of State, means the Secretary of State;
 - (b) in relation to a warrant issued by a person holding judicial office, means any person holding any judicial office that would have entitled him to issue the warrant; and
 - (c) in relation to protected information obtained under an authorisation under Part III of the ^{M92}Police Act 1997, means (subject to sub-paragraph (7)) an authorising officer within the meaning of section 93 of that Act.
- (7) Section 94 of the M93 Police Act 1997 (power of other persons to grant authorisations in urgent cases) shall apply in relation to—
 - (a) an application for permission for the giving of section 49 notices in relation to protected information obtained, or to be obtained, under an authorisation under Part III of that Act, and

Duration of permission

- 7 (1) A permission granted by any person under any provision of this Schedule shall not entitle any person to give a section 49 notice at any time after the permission has ceased to have effect.
 - (2) Such a permission, once granted, shall continue to have effect (notwithstanding the cancellation, expiry or other discharge of any warrant or authorisation in which it is contained or to which it relates) until such time (if any) as it—
 - (a) expires in accordance with any limitation on its duration that was contained in its terms; or
 - (b) is withdrawn by the person who granted it or by a person holding any office or other position that would have entitled him to grant it.

Formalities for permissions granted by the Secretary of State

THE TRIBUNAL

Membership of the Tribunal

 - (5) A member of the Tribunal may be removed from office by Her Majesty on an Address presented to Her by both Houses of Parliament.
 - (6) If the Scottish Parliament passes a resolution calling for the removal of a member of the Tribunal, it shall be the duty of the Secretary of State to secure that a motion for the presentation of an Address to Her Majesty for the removal of that member, and the resolution of the Scottish Parliament, are considered by each House of Parliament.

Officers

- 5 (1) The Secretary of State may, after consultation with the Tribunal and with the approval of the Treasury as to numbers, provide the Tribunal with such officers as he thinks necessary for the proper discharge of their functions.
 - (2) The Tribunal may authorise any officer provided under this paragraph to obtain any documents or information on the Tribunal's behalf.

Parliamentary disqualification

In Part II of Schedule 1 to the M96House of Commons Disqualification Act 1975 and in Part II of Schedule 1 to the M97Northern Ireland Assembly Disqualification Act 1975 (bodies whose members are disqualified) there shall be inserted (at the appropriate places) the following entry—
