#### Commissioners

# Delegation of [F1 functions of the Investigatory Powers Commissioner for Northern Ireland].

(1) Anything authorised or required by or under any enactment F2...to be done by [F3the Investigatory Powers Commissioner for Northern Ireland] may be done by any member of the staff of that Commissioner who is authorised for the purpose (whether generally or specifically) by that Commissioner.
