Form and content

- (2) A commonhold association may adopt provisions of the regulations for its [^{F4}articles].
- (3) The regulations may include provision which is to have effect for a commonhold association whether or not it is adopted under sub-paragraph (2).
- (4) A provision of the [^{F4}articles] shall have no effect to the extent that it is inconsistent with the regulations.
- (5) Regulations under this paragraph shall have effect in relation to [^{F5}articles]—
- (a) irrespective of the date of the [^{F6}articles], but
 - (b) subject to any transitional provision of the regulations.
- [^{F7}(6) Section 20 of the Companies Act 2006 (default application of model articles) does not apply to a commonhold association.]

- (2) If the commonhold association makes an application under this sub-paragraph the Registrar shall arrange for [^{F11}altered articles] to be kept in his custody, and referred to in the register, in place of the unaltered version.
- (3) An application under sub-paragraph (2) must be accompanied by a certificate given by the directors of the commonhold association that the altered [^{F12}articles] comply with regulations under paragraph 2(1).
- (4) Where the Registrar amends the register on an application under sub-paragraph (2) he shall make any consequential amendments to the register which he thinks appropriate.
