## 2002 CHAPTER 29

### PART 12

#### MISCELLANEOUS AND GENERAL

##### *General*

#### 460 Finance

- (1) The following are to be paid out of money provided by Parliament—
  - (a) any expenditure incurred by any Minister of the Crown under this Act;
  - (b) any increase attributable to this Act in the sums payable out of money so provided under any other enactment.
- (2) Any sums received by the Secretary of State in consequence of this Act are to be paid into the Consolidated Fund.
- [<sup>F1</sup>(3) Subject to anything in this Act—
  - (a) any sums received by the Director of Public Prosecutions <sup>F2</sup>... or the Director of the Serious Fraud Office in consequence of this Act are to be paid into the Consolidated Fund; [<sup>F3</sup>and]
  - (b) any sums received by the Director of Public Prosecutions for Northern Ireland in consequence of this Act are to be paid to the [<sup>F4</sup>Department of Justice in Northern Ireland][<sup>F5</sup>, and
  - (c) any sums received by the Financial Conduct Authority in consequence of this Act are to be paid into the Consolidated Fund.]]
