Local authority services

49 Payments to foster parents E+W

- (1) The appropriate person may by order make provision as to the payments to be made—
 - (a) by a [^{F1}local authority] in England or Wales or a person exercising functions on its behalf to a local authority foster parent with whom any child is placed by that authority or person under section [^{F2}22C] of the Children Act 1989[^{F3}or section 81 of the Social Services and Well-being (Wales) Act 2014];
 - (b) by a voluntary organisation to any person with whom any child is placed by that organisation under section 59(1)(a) of [^{F4}the Children Act 1989].

(2) In subsection (1)—

"appropriate person" means-

- (a) the Secretary of State, in relation to a [^{F1}local authority] in England;
- (b) the Assembly, in relation to a [^{F1}local authority] in Wales;

F5....

[^{F6}"local authority foster parent" has the same meaning as in section 105(1) of the Children Act 1989;

"voluntary organisation" has the same meaning as in the Children Act 1989.]

- (3) In section 23(2)(a) of the Children Act 1989, at the end insert . " (subject to section 49 of the Children Act 2004) "
- (4) In section 59(1)(a) of that Act, at the end insert " (subject to section 49 of the Children Act 2004) ".
