Road Traffic Act 1988 (c. 52)

- 9 (1) Section 99 (duration of licences) is amended as follows.
- (2) In subsection (2A), omit “and its counterpart”.

 - (b) in paragraph (b), omit “or in its counterpart”, and
 - (c) omit “and its counterpart”.
