

(2) Subsection (1) does not affect the existing power under section 3(12) of that Act to increase the financial limit specified in section 3(5)(c). (3) This section ceases to have effect on the appointed day. (4) In this section "the appointed day" means the day on which section 3A(1) to (5) of the 1993 Act (as substituted by section 9 of this Act) come into force by virtue of an order under section 79 of this Act. **Commencement Information** S. 10 in force at 27.2.2007 by S.I. 2007/309, art. 2, Sch. 
