227 [F1Local Healthwatch organisations: annual reports]

- (1) Subsection (2) has effect for the purposes of section 222(7).
- (2) In relation to any arrangements made under section 221(1)^{F2}..., the "required provision about annual reports" is—
 - (a) provision-
 - (i) requiring^{F3}... the preparation by [^{F4}the Local Healthwatch organisation] for each financial year of a report in relation to the activities of [^{F5}the organisation] in the year (so far as they are activities specified in section 221(2) for the local authority's area and carried on [^{F6}under the arrangements or arrangements made] in pursuance of the arrangements);
 - (b) provision requiring that each such report must comply with the requirements mentioned in subsection (3);
 - (c) provision requiring each such report to be prepared by 30th June after the end of the financial year concerned; and
 - (d) provision requiring that, once such a report has been prepared—
 - (i) copies of it are to be made publicly available in such manner as the person preparing it, after having had regard to any guidance issued

by the Secretary of State that may be in force at the time, considers

(9) In this section—

"financial year" means a period of 12 months ending with 31st March; [F25. Local Healthwatch contractor" has the meaning given by section 223;] "overview and scrutiny committee" has the meaning given by section 226(8).

(10) Power to give directions for purposes of this section includes power to vary or revoke directions given in previous exercise of the power.
