INSURANCE COMPANIES ETC

Repeal of section 737D of ICTA

- 35 (1) In ICTA, omit section 737D (power to provide that manufactured payments are to be treated as income eligible for relief under section 438).
- (2) In consequence of sub-paragraph (1), omit—
- (a) section 83(1) of FA 1995,
 - (b) section 139(6) of FA 2006, and
 - (c) paragraph 175 of Schedule 1 to ITA 2007.
