206 Saving for informal oversight

- (1) Nothing in this Part prevents the Bank of England from having dealings with the operators of payment systems [^{F1}, DSA service providers][^{F2}, or persons who provide services in relation to payment systems,][^{F3}or DSA service providers] to which this Part does not apply.
- (2) Nothing in this Part prevents the Bank from having dealings, other than through the provisions of this Part, with the operators of payment systems [^{F4}, DSA service providers][^{F5}, or persons who provide services in relation to payment systems,][^{F6}or DSA service providers] to which this Part does apply.
