PROSPECTIVE

51 Power of [^{F1}Auditor General for Wales] to require information

- (1) At any time after the appointment of a person under this Chapter in relation to an entity, the [^{F2}Auditor General for Wales] may for the purpose specified in subsection (2) require the entity to produce to [^{F3}the Auditor General for Wales] —
 - (a) the accounts audited by the person pursuant to section 43 or under section 44, or
 - (b) any other document or information relating to the entity to which the person has or had a right of access under or pursuant to this Chapter.
- (2) The purpose referred to in subsection (1) is to enable [^{F4}the Auditor General for Wales] to secure that persons appointed by the [^{F5}Auditor General for Wales] under this Chapter maintain proper standards.
