Funding

101 Financial resources: conditions

- (1) Financial resources provided [^{F1}by the Secretary of State under section 100] may be provided subject to conditions [^{F2}, subject to section 101A].
- (2) The conditions may [^{F3}(among other things)] include—
 - (a) information conditions;
 - ^{F4}(b)
 - (c) repayment conditions.
- (3) Information conditions are conditions which—
 - (a) require the [^{F5}Secretary of State], or a person designated by the [^{F5}Secretary of State], to be given access to a person's accounts and documents and to be given rights in relation to a person's computers and associated apparatus and material, or
 - (b) require a person to whom financial resources are provided to give to the [^{F6}Secretary of State] such information as the [^{F6}Secretary of State] may request for the purpose of carrying out [^{F7}functions under this Part].

(6) Repayment conditions are conditions which—

- (a) enable the [^{F10}Secretary of State] to require the repayment (in whole or part) of sums paid by the [^{F10}Secretary of State] if any of the conditions subject to which the sums were paid is not complied with;
- (b) require the payment of interest in respect of any period in which a sum due to the [^{F11}Secretary of State] in accordance with any condition is unpaid.
