Miscellaneous amendments of FSMA 2000

49 Parliamentary control of statutory instruments

- (1) Section 429 of FSMA 2000 (Parliamentary control of statutory instruments) is amended as follows.
- (2) In subsection (1) (orders subject to the affirmative resolution procedure)—
 - (a) in paragraph (a)—
 - (i) after "section" insert "1J, 3B(4), 3F(6), 55C, ",
 - (ii) after "or (e)," insert "138K(6)(c), 192B(6), 204A(7), 213(1A), ", and
 - (iii) after "236(5)," insert "285(4), 380(12), 382(15), 384(13),", and
 - (b) omit paragraph (b).
- (3) In subsection (8)—
 - (a) after "under section" insert "3G(1), 137D(1)(b), ",
 - (b) after "165A(2)(d)" insert ", 192A(4)", and
 - (c) after "which" insert "section 22B or 23A or ".
