SUPPLEMENTARY AND FINAL PROVISION

Territorial application

207 Territorial application of this Act

- (1) This Act applies only to processing of personal data described in subsections [F¹ (1A) and (2)].

[F²(1A) In the case of the processing of personal data to which Part 2 (the UK GDPR) applies, it applies to the types of such processing to which the UK GDPR applies by virtue of Article 3 of the UK GDPR.]

- (2) [F³In the case of the processing of personal data to which Part 2 does not apply, it applies where such processing is carried out] in the context of the activities of an establishment of a controller or processor in the United Kingdom, whether or not the processing takes place in the United Kingdom.

- (4) [F⁵Subsections (1), (1A) and (2)] have effect subject to any provision in or made under section 120 providing for the Commissioner to carry out functions in relation to other processing of personal data.

- (5) Section 3(14)(c) does not apply to the reference to the processing of personal data in subsection (2).

- (7) In this section, references to a person who has an establishment in the United Kingdom include the following—

(a) an individual who is ordinarily resident in the United Kingdom,
