(2) Notwithstanding any stipulation to the contrary, a purchaser of any interest in or charge upon land [^{F4}(not being registered land)] shall be entitled to have any instrument creating a power of attorney which affects his title, or [^{F5}a copy] thereof or of the material portions thereof delivered to him free of expense.
