An Act to amend an Act of the Fifth and Sixth Years of the Reign of His late Majesty King William the Fourth relating to Highways. [17th August 1839]

1 Proprietors of Railroad to maintain Gates where any Railroad crosses the Highway, &c.

Wherever a railroad crosses or shall hereafter cross [^{F1}any turnpike road or any highway or statute labour road for carts or carriages in Great Britain][^{F1}the carriageway of a public road (within the meaning of the Roads (Scotland) Act 1984)], the proprietors or directors of the company of proprietors of the said railroad shall make and maintain good and sufficient gates across each end of such [^{F2}turnpike or other road as aforesaid][^{F2}carriageway] at each of the said crossings, and shall employ good and proper persons to open and shut such gates, so that the persons, carts, or carriages passing along such [^{F3}turnpike or highway][^{F3}carriageway] shall not be exposed to any danger or damage by the passing of any carriages or engines along the said railroad;
