



# Sea Fisheries (Scotland) Amendment Act 1885

1885 CHAPTER 70 48 and 49 Vict

## 6 Fishery Board may require statistics of sea fisheries.

[<sup>F1</sup>The Scottish Ministers] shall have power to require all fishermen and other persons belonging to British sea-fishing boats, and all fish curers catching or curing any kind of sea fish in Scotland, or in [<sup>F2</sup>the Scottish zone], to make returns, in such form and at such periods as may be prescribed by . . . <sup>F3</sup>the [<sup>F1</sup>Scottish Ministers], of all sea fish which are caught or cured by them respectively.

The [<sup>F1</sup>Scottish Ministers], before [<sup>F4</sup>prescribing] the form or period . . . <sup>F3</sup> for any such return, shall communicate with the [<sup>F5</sup>Minister of Agriculture, Fisheries and Food], and copies of all such returns shall be immediately furnished by the [<sup>F1</sup>Scottish Ministers] to the [<sup>F5</sup>Minister of Agriculture, Fisheries and Food].

Any person failing to make a full and correct return under this section shall be guilty of an offence against the . . . <sup>F6</sup>, and shall be liable on summary conviction to a fine not exceeding [<sup>F7</sup>level 2 on the standard scale][<sup>F8</sup>and sections 12(2) and 14 of the <sup>M1</sup>Sea Fisheries Act 1968 shall apply to an offence under this section as they apply to an offence under section 5 or 10 of that Act [<sup>F9</sup>or section 2 of the <sup>M2</sup>Fishery Limits Act 1976].]
