



# Crofters Holdings (Scotland) Act 1886

1886 CHAPTER 29 49 and 50 Vict

An Act to amend the Law relating to the Tenure of Land by Crofters in the Highlands and Islands of Scotland, and for other purposes relating thereto. [25th June 1886]
