**The National Health Service Re-organisation (Retirement  
of Senior Officers) (Scotland) (Amendment) Regulations 1975**

<i>Made</i>	- - -	8th January 1975
<i>Laid before Parliament</i>		10th January 1975
<i>Coming into Operation</i>		31st January 1975

In exercise of the powers conferred on me by section 34A of the National Health Service (Scotland) Act 1972(a) as inserted by the National Health Service Re-organisation Act 1973(b) and of all other powers enabling me in that behalf, I hereby make the following regulations:—

*Citation and commencement*

1. These regulations may be cited as the National Health Service Re-organisation (Retirement of Senior Officers) (Scotland) (Amendment) Regulations 1975 and shall come into operation on 31st January 1975.

*Interpretation*

2.—(1) In these regulations “principal regulations” means the National Health Service Re-organisation (Retirement of Senior Officers) (Scotland) Regulations 1974(c).

(2) The Interpretation Act 1889(d) shall apply for the interpretation of these regulations as it applies for the interpretation of an Act of Parliament.

*Dates of election to retire and of retirement*

3. In relation to any person being an officer listed in the schedule to these regulations and being a person to whom regulation 3(1)(a) of the principal regulations applies the principal regulations are hereby amended as follows:—

(a) in regulation 3 (persons to whom the regulations apply)

(i) in sub-paragraph (b) of paragraph (1) there shall be added after “paragraph (2)” the words “as amended”.

(ii) in sub-paragraph (c) of paragraph (2) for “31st January 1975” there shall be substituted “31st January 1976”.

(iii) in sub-paragraph (d) of paragraph (2) for “1st January 1975” there shall be substituted “1st January 1976”.

(b) in regulation 5 (factors governing payment of benefits) in paragraph (c) for “31st March 1975” there shall be substituted “31st March 1976”.

(c) in schedule 2 (acceptance of other employment) in sub-paragraph (a) of paragraph 2 for "31st March 1975" there shall be substituted "31st March 1976".

#### EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These Regulations amend the National Health Service Re-organisation (Retirement of Senior Officers) (Scotland) Regulations 1974, which provide for certain senior officers to elect for early retirement on enhanced pension terms, by extending the final date for election to retire early from 31st January 1975 to 31st January 1976 for specified officers in the Works Group.
