The Licensing (Fees) Order 1978

In exercise of the powers conferred upon me by sections 29(1) and 198(2) of the Licensing Act 1964(a), I hereby make the following Order:—

1.—(1) This Order may be cited as the Licensing (Fees) Order 1978 and shall come into operation on 1st January 1979.

(2) The Interpretation Act 1889(b) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

2. The fees which may be charged in respect of matters arising under the Licensing Act 1964 in accordance with section 29 of that Act shall be the fees set out in the Schedule to this Order.

3. The Licensing (Fees) Order 1976(c) is hereby revoked.
