CIVIL AVIATION

The Civil Aviation (Air Travel Organisers' Licensing) (Third Amendment) Regulations 1979

Made - - - - 3rd January 1979

Laid before Parliament 12th January 1979

Coming into Operation 1st April 1979

The Secretary of State, in exercise of his powers under Section 26 of the Civil Aviation Act 1971(a) and of all other powers enabling him in that behalf and after consultation with the Civil Aviation Authority as required by Section 26(2) of that Act, and with the Council on Tribunals as required by Section 10 of the Tribunals and Inquiries Act 1971(b), hereby makes the following Regulations:—

1. These Regulations may be cited as the Civil Aviation (Air Travel Organisers' Licensing) (Third Amendment) Regulations 1979 and shall come into operation on 1st April 1979.

2. The Civil Aviation (Air Travel Organisers' Licensing) Regulations 1972(c), as amended(d), shall be further amended as follows:—

For Regulation 3(4), there shall be substituted the following:—

“If the holder of a current licence applies for the grant of another licence in continuation of or in substitution for the current licence and his application:

- (a) contains such particulars with respect to such matters relating to his fitness, resources and financial arrangements as the Authority may have specified in respect of the holder of that licence in a notice in writing served on him not less than four months before the expiration of the term of the current licence (or in the case of a licence having a term of less than six months at the time of the grant of the licence); and
- (b) is accompanied by the fee payable under Section 9 of the Act; and
- (c) is served on the Authority not less than three months (or half the term of the current licence whichever be the less) before the expiration of the term of the current licence,

then, unless the application is withdrawn and without prejudice to the

Authority's power to revoke, suspend or vary the current licence, the current licence shall not cease to be in force by reason only of the expiration of that term until the Authority gives its decision on the application."

EXPLANATORY NOTE

(This Note is not part of the Regulations.)

These Regulations further amend the Civil Aviation (Air Travel Organisers' Licensing) Regulations 1972 by providing that an application by the holder of a current licence for the grant of another licence, made three months before the date of expiry of the current licence, will no longer have the effect of keeping the current licence in force after the date when it would otherwise expire unless the application is accompanied by the appropriate fee and by such particulars as the Civil Aviation Authority may have specified in respect of the holder of that licence in a notice in writing served on him not less than four months before the expiration of the term of the current licence.
