The Industrial Training (Transfer of the Activities of Establishments) Order 1981

Made - - - - 20th July 1981 Coming into Operation 26th August 1981

The Secretary of State, on the recommendation of the Manpower Services Commission, and in exercise of the powers conferred on him by section 9A(2) of the Industrial Training Act 1964(1) and of all other powers enabling him in that behalf, hereby makes the following Order:—

Citation and commencement

1. This Order may be cited as the Industrial Training (Transfer of the Activities of Establishments) Order 1981 and shall come into operation on 26th August 1981.

Transfer of Establishments' Activities

2. The activities carried on at each establishment specified in column 1 of the Schedule to this Order, being an establishment of an employer in the industry of an industrial training board, shall instead of being included for the purposes of the Act in the industry of the industrial training board established by the industrial training order specified in column 2 of that Schedule, be included for those purposes in the industry of the industrial training board established by the industrial training order specified in column 3 of that Schedule.
