The Food and Drugs (Scotland) Act 1956 (Transfer of Enforcement Functions) Regulations 1983

In exercise of the powers conferred on me by sections 4 and 7 as read with sections 26(3) and 56 of the Food and Drugs (Scotland) Act 1956(a), and of all other powers enabling me in that behalf, and after consultation in accordance with section 56(6) of the said Act with such organisations as appear to me to be representative of interests substantially affected by these regulations, I hereby make the following regulations:—

- 1. These regulations may be cited as the Food and Drugs (Scotland) Act 1956 (Transfer of Enforcement Functions) Regulations 1983 and shall come into operation on 1 April 1983.
- 2. In each of the regulations specified in columns 1 and 2 of Schedule 1 to these regulations, there shall be substituted, in the regulation specified in column 3 of that Schedule, for the word "regional" the word "district".
- 3. In each of the regulations specified in columns 1 and 2 of Schedule 2 to these regulations, there shall be substituted for the regulation specified in column 3 of that Schedule, the following regulation:—
 - "Each district and islands council shall enforce and execute the provisions of these regulations within their area.".
- **4.** In each of the regulations specified in columns 1 and 2 of Schedule 3 to these regulations, there shall be substituted for the regulation specified in column 3 of that Schedule, the following regulation:—

"In this regulation, 'local authority' means a district or islands council within the meaning of the Local Government (Scotland) Act 1973."(b).

"'local authority' means a district or islands council within the meaning of the Local Government (Scotland) Act 1973.".
