**The Local Authority Grants (Termination) (Scotland)
Order 1986**

Coming into Operation 1st April 1986

The Secretary of State, in exercise of the powers conferred on him by Section 15 of the Local Government (Scotland) Act 1975(a), and of all other powers enabling him in that behalf, hereby makes the following order:-

Citation and commencement

1. This order may be cited as the Local Authority Grants (Termination) (Scotland) Order 1986 and shall come into operation on 1st April 1986.

2. With effect from the commencement of the year 1986-87, no grant shall be paid under the local authority grant provisions specified in Schedules 1 and 2 to this order.

Repeals and revocation

3.—(1) The local authority grant provisions specified in Schedule 1 to this order are hereby repealed to the extent specified in that Schedule.

(2) The local authority grant provisions specified in Schedule 2 to this order are hereby revoked to the extent specified in that Schedule.
