ROAD TRAFFIC

The Motor Vehicles (Driving Licences) (Amendment) Regulations 1986

Made - - - 23rd April 1986

Laid before Parliament 30th April 1986

Coming into Operation 1st September 1986

The Secretary of State for Transport, in exercise of the powers conferred by sections 88 and 107 of the Road Traffic Act 1972(a), and now vested in him(b), and of all other enabling powers, and after consultation with representative organisations in accordance with section 199(2) of that Act and with the approval of the Treasury, hereby makes the following Regulations:—

- 1. These Regulations may be cited as the Motor Vehicles (Driving Licences) (Amendment) Regulations 1986 and shall come into operation on 1st September 1986.
- 2. For regulation 6 (Fees for licences) of the Motor Vehicles (Driving Licences) Regulations 1981(c) there shall be substituted the following regulation:—

"Fees for licences

6. The fee payable for a licence granted on or after 1st September 1986 shall be, in the case of a licence of a description, and in certain instances granted in particular circumstances, specified in column (1) of the Table in this Regulation, the fee specified in relation to that licence in column (2) of that Table.

| 1. A licence granted to a person who, at no time during the period of 10 years ending on the date of coming into force of the licence, has been granted a licence for any class of vehicle (other than a licence granted in exchange for a subsisting one). | £15.00 |
| 2. A provisional or a first full licence granted to a person whose last licence was a provisional licence granted before 1st October 1982. | £15.00 |
| 3. A licence (not being a first full licence or a licence falling within paragraphs 1 or 2 above) which is | £5.00 |
| (a) a provisional licence, or a full licence not authorising the driving of vehicles of any class in groups A, B, C or E, and which authorises its holder to drive, as a provisional licence holder, vehicles of any class in group D— | |
