The Richmond, Twickenham and Roehampton Healthcare National Health Service Trust (Transfer of Trust Property) Order 1994

The Secretary of State for Health, in exercise of the powers conferred on her by section 92(1) of the National Health Service Act 1977(1) and of all other powers enabling her in that behalf, having regard to the change in the arrangements for the administration of hospitals and other establishments and facilities formerly managed by the Richmond, Twickenham and Roehampton Health Authority resulting from the establishment of the Richmond, Twickenham and Roehampton Healthcare National Health Service Trust(2), having consulted Kingston and Richmond Health Authority(3) and that Trust in accordance with section 92(3) of that Act, hereby makes the following Order:

Citation, commencement and interpretation

- 1.—(1) This Order may be cited as the Richmond, Twickenham and Roehampton Healthcare National Health Service Trust (Transfer of Trust Property) Order 1994 and shall come into force on 9th March 1994.
 - (2) In this Order—

"the Authority" means the Kingston and Richmond Health Authority;

"the Trust" means the Richmond, Twickenham and Roehampton Healthcare National Health Service Trust;

"the trust property" means the items specified in a schedule of trust property prepared by and agreed upon by Richmond, Twickenham and Roehampton Health Authority and the Trust on

15th March 1993, which schedule has been signed on behalf of both the Authority and the Trust.

Transfer of trust property

2. On 9th March 1994 the trust property shall be transferred from the Authority to the Trust.
