**ROAD TRAFFIC**

**The Road Traffic (Special Parking Area)  
(London Borough of Croydon) Order 1997**

Whereas the council of the London borough of Croydon has applied to the Secretary of State for an order to be made under section 76 of the Road Traffic Act 1991(1) and the Secretary of State has consulted the Commissioner of Police of the Metropolis in accordance with section 76(2) of that Act: NOW, the Secretary of State for Transport, in exercise of the powers conferred by section 76(1) and section 77(6) of Road Traffic Act 1991 and of all other powers enabling him in that behalf, hereby makes the following Order:—

**Citation and commencement**

1. This Order may be cited as the Road Traffic (Special Parking Area) (London Borough of Croydon) Order 1997 and shall come into force on 1st July 1997.

**Revocation**

2. The Road Traffic (Special Parking Area) (London Borough of Croydon) Order 1994(2) and the Road Traffic (Special Parking Area) (London Borough of Croydon) (Amendment) Order 1995(3) are hereby revoked.

**Interpretation**

3. In this Order—

“the 1984 Act” means the Road Traffic Regulation Act 1984(4);

“the 1991 Act” means the Road Traffic Act 1991;

“the special parking area” means the area designated as a special parking area by article 4 of this Order;

a reference in the Schedule to this Order to a number followed by the letter “m” is a reference to that number of metres; and

where a road referred to in the Schedule to this Order (“the main road”) is joined by another road (“the side road”), whether or not that other road is referred to in that Schedule, and the footway to the main road runs on either side of the mouth of the side road, the junction between the two roads shall be taken to be an imaginary line drawn across the mouth of the side road between the respective ends of the back line of the footway to the main road on each side.

#### **Designation of special parking area**

4. The Secretary of State hereby designates as a special parking area the London borough of Croydon except the roads named or described in the Schedule to this Order.

#### **Modification of the Road Traffic Regulation Act 1984**

5.—(1) Section 55 of the 1984 Act (financial provisions relating to designation orders) shall have effect in relation to the London borough of Croydon as if—

(a) at the end of subsection (1) there were inserted the words “and of the income from additional parking charges (within the meaning of section 74(8) of the Road Traffic Act 1991) received by them in respect of vehicles found within special parking area and the expenditure incurred by them in the discharge of functions exercisable by them in relation to the special parking area by virtue of Part II of the Road Traffic Act 1991”; and

(b) after subsection (1) there were inserted the following subsection—

“(1A) In subsection (1) above, references to “the special parking area” are to the area designated as a special parking area by the Road Traffic (Special Parking Area) (London Borough of Croydon) Order 1997.”

(2) Section 102(2) of the 1984 Act (charges for removal, storage and disposal of vehicles) shall have effect in relation to a vehicle found in the special parking area as if, in paragraph (d), for the words “a parking place” to the end there were substituted—

“(i) a parking place designated under section 6, 9 or 45 of this Act or otherwise provided or controlled by that authority, or

(ii) a place where the vehicle was stationary in circumstances in which an offence would have been committed in respect of the vehicle but for section 76(3) of the Road Traffic Act 1991,

as they may require.”

#### **Modification of the Road Traffic Act 1991**

6.—(1) Section 70 of the 1991 Act (exemptions from provisions relating to the immobilisation of vehicles in parking places) shall have effect in relation to a vehicle found in the special parking area as if, in subsections (1) and (2), after the words “section 69(1)” there were inserted the words “or section 77(4)”.

(2) Section 71 of the 1991 Act (representations in relation to removal or immobilisation of vehicles) shall have effect in relation to a vehicle found in the special parking area as if, for subsection (4), there were substituted the following subsection—

“(4) The grounds are—

- (a) that there were no reasonable grounds for the parking attendant concerned to believe that either—
  - (i) the vehicle had been permitted to remain at rest in the parking place in circumstances specified in section 66(2)(a), (b) or (c) of this Act, or
  - (ii) the vehicle had been permitted to remain at rest in a special parking area (other than in a designated parking place) in circumstances in which an offence would have been committed in respect of the vehicle but for section 76(3) of this Act;
- (b) that the vehicle had been permitted to remain at rest in the place in question by a person who was in control of the vehicle without the consent of the owner;
- (c) that the place at which the vehicle was at rest was neither a designated parking place nor in a special parking area;
- (d) in a case within subsection (1)(d) above, that, by virtue of an exemption given by section 70 of this Act, neither section 69 nor 77(4) of this Act applied to the vehicle at the time in question; or
- (e) that the penalty or other charge in question exceeded the amount applicable in the circumstances of the case.”

(3) Section 74(8) of the 1991 Act (fixing of certain parking and other charges for London) shall have effect in relation to the London borough of Croydon as if, after the words “section 69”, there were inserted the words “or section 77(4)”.

(4) Section 79(2) of the 1991 Act (application to Crown and visiting forces) shall have effect in relation to a vehicle found in the special parking area as if, for “66 and 69 to 71”, there were substituted “66, 69 to 71, 76 and 77”.

(5) Schedule 6 to the 1991 Act (parking penalties) shall have effect in relation to a vehicle found in the special parking area as if—

- (a) in sub-paragraph (c) of paragraph 2(4), for the words “the parking place” there were substituted the words “the place in question”, and
- (b) in sub-paragraph (d) of paragraph 2(4), the word “designation” were omitted.

## THE SCHEDULE

Regulation 4

### ROADS IN THE LONDON BOROUGH OF CROYDON EXCLUDED FROM THE SPECIAL PARKING AREA

1. A23 between the borough boundary with the London borough of Lambeth and the district boundary with Reigate and Banstead in the County of Surrey.
2. A232 between the borough boundary with the London borough of Sutton and the borough boundary with the London Borough of Bromley.

#### *Roads adjacent to A23*

3. Acacia Road between its junction with London Road (A23) and a point 3m north east of the south western rear boundary of 1575 London Road.
4. Alton Road—
  - (a) (east arm) between its junction with Purley Way (A23) and a point 2m north east of the party wall between 49 and 51 Alton Road;
  - (b) (west arm)—
    - (i) (north side) between its junction with Purley Way (A23) and a point opposite a point 16m east of the party wall between 55 and 57 Alton Road;
    - (ii) (south side) between its junction with Purley Way (A23) and a point 14.5m east of the party wall between 55 and 57 Alton Road.
5. Banstead Road (A2022) between its junction with Brighton Road (A23) and a point level with the boundary between 37 and 39 Banstead Road (A2022).
6. Beatrice Avenue between its junction with London Road (A23) and a point opposite the south western boundary of “Acklands”, London Road.
7. Beddington Farm Road between its junction with Purley Way (A23) and a point 51.5m south west of the north eastern flank wall of 220 Purley Way.
8. Boston Road between its junction with Thornton Road (A23) and a point 1m east of the eastern rear wall of 299 Thornton Road.
9. Brighton Road (A235)—
  - (a) (north west side) between its junction with the A23 and a point 2m south west of the party wall between 924 and 926 Brighton Road;
  - (b) (south east side) between its junction with the A23 and a point opposite the party wall between 915 and 917 Brighton Road.
10. Broughton Road between its junction with Thornton Road (A23) and a point 8.5m north west of the party wall between 107 and 109 Broughton Road.
11. Canterbury Road between its junction with Thornton Road (A23) and a point opposite the party wall between 178 and 180 Canterbury Road.
12. Cecil Road between its junction with Thornton Road (A23) and a point 20m west of the eastern flank wall of 298 Thornton Road.
13. Chipstead Valley Road between its junction with Brighton Road (A23) and a point opposite the party wall between 28 and 30 Chipstead Valley Road.
14. Coldharbour Road between its junction with Purley Way (A23) and a point 10m west of the east boundary between 117 Coldharbour Road.

15. Colliers Water Lane between its junction with London Road (A23) and a point 1.5m south west of the north eastern rear boundary of 794 London Road.
16. Colvin Road between its junction with Thornton Road (A23) and a point 4m north west of the party wall between 19 and 21 Colvin Road.
17. Commerce Way between its junction with Purley Way (A23) and a point 26.5m south west of the north eastern flank wall of 230 to 250 Purley Way.
18. Craignish Avenue between its junction with London Road (A23) and a point 2m west of the eastern rear boundary of 1346 London Road.
19. Denning Avenue between its junction with Purley Way (A23) and a point 6m west of the party wall between 71 and 73 Denning Avenue.
20. Drake Road between its junction with Purley Way (A23) and a point 4.5m west of the common boundary of 9 and 11 Drake Road.
21. Drury Crescent between its junction with Purley Way (A23) and a point 52.5m north east of the north eastern kerbline of Purley Way (measured on the north west side of Drury Crescent).
22. Ederline Avenue between its junction with London Road (A23) and a point 5.5m south west of the north eastern flank wall of 1 to 8 Kintyre Close.
23. Edgehill Road between its junction with Purley Way (A23) and a point 3.5m west of the common boundary between 23 and 25 Edgehill Road.
24. Fairlands Avenue between its junction with Thornton Road (A23) and a point 12.5m south east of the south eastern flank wall of 1 Fairlands Avenue.
25. Fairmead Road between its junction with Purley Way (A23) and a point 23m west of the common boundary between 13 and 15 Fairmead Road.
26. Fairview Road between its junction with London Road (A23) and a point 6.5m north east of the party wall between 1 and 3 Fairview Road.
27. Foss Avenue between its junction with Purley Way (A23) and a point 9m west of the eastern boundary of 83 Foss Avenue.
28. Foxley Lane (A2022) between its junction with Foxley Lane (A23) and a point 13m west of the boundary between 8 and 10 Foxley Lane (A2022).
29. Galpins Road between its junction with London Road (A23) and a point 4m south west of the party wall between Nos. 4 and 6 Galpins Road.
30. Godson Road between its junction with Purley Way (A23) and a point opposite the western flank wall of 43 Godson Road.
31. Godstone Road between its junction with Purley Road and an imaginary straight line drawn between a point on the north eastern kerbline opposite the south eastern flank wall of 1 Godstone Road and a point 16m north west of the north western boundary of 2 Godstone Road, measured along the southern kerbline.
32. Goldwell Road between its junction with London Road (A23) and a point 5m south west of the north eastern flank wall of 1 to 40 Jubilee Court.
33. Gonville Road between its junction with Thornton Road (A23) and a point 13m south east of the south eastern flank wall of 1 Gonville Road.
34. Grovelands Road between its junction with Brighton Road (A23) and a point 3m south east of the north western boundary of 76 Brighton Road.

- 35.** Harcourt Road between its junction with Thornton Road (A23) and a point 7.5m south east of the south eastern rear wall of 225 Thornton Road.

- 37.** Heathview Road between its junction with London Road (A23) and a point 19.5m north east of the south western flank wall of 954 London Road.
- 38.** Highfield Road between its junction with Purley Way (A23) and a point 1m north east of the south western flank wall of 1 Ensign Close.
- 39.** High Street, Purley between its junction with Purley Road/Whytecliffe Road South and a point 1.5m south of the party wall between 6 and 8 High Street.
- 40.** Imperial Way—
- (a) (north side) between its junction with Purley Way (A23) and a point 3m west of the western flank wall of 2 Imperial Way;
  - (b) (south side) between its junction with Purley Way (A23) and a point 20m west of the western flank wall of 2 Imperial Way.
- 41.** Jennett Road between its junction with Purley Way (A23) and a point 19.5m north east of the south western flank wall of 287 Purley Way.
- 42.** Keston Road between its junction with Thornton Road (A23) and a point 21m north west of the party wall between 1 and 3 Keston Road.
- 43.** Kilmartin Avenue between its junction with London Road (A23) and a point 24m north east of the south western flank wall of 1136 London Road.
- 44.** Langdale Road between its junction with London Road (A23) and a point 8.75m south west of the party wall between 1a and 3a Langdale Road.
- 45.** Lansdowne Road between its junction with Brighton Road (A23) and a point 2.5m north west of the north west flank wall of 11 Brighton Road.
- 46.** Leander Road between its junction with London Road (A23) and a point 1m north east of the south western rear boundary of 991 London Road.
- 47.** Limes Avenue between its junction with Purley Way (A23) and a point 2m west of the western rear wall of 360 Purley Way.
- 48.** Limpsfield Avenue between its junction with Thornton Road (A23) and a point 6.5m north west of the south eastern flank wall of 98/100 Thornton Road.
- 49.** Lion Green Road between its junction with Brighton Road (A23) and a point 1m north of the south eastern boundary of 20 Lion Green Road.
- 50.** Lodge Avenue between its junction with Purley Way (A23) and a point opposite the western rear boundary of 374 Purley Way.
- 51.** London Road (A235)—
- (a) (north east side) between its junction with London Road (A23) and a point 8.5m south east of the party wall between 744 and 746 London Road;
  - (b) (south west side) between its junction with London Road (A23) and a point 20m south east of the party wall between 727 and 729 London Road.
- 52.** Lyndhurst Road between its junction with London Road (A23) and a point 2m south west of the south western flank wall of 2a Lyndhurst Road.

**53.** Malcolm Road between its junction with Brighton Road (A23) and a point opposite the western boundary of 110—112 Brighton Road.

**54.** Malvern Road between its junction with London Road (A23) and a point 4m south west of the south western flank wall of 1a Malvern Road.

**55.** Marsden Crescent between its junction with Thornton Road (A23) and a point 5.5m east of the western flank wall of 243 Thornton Road.

**56.** Marlpit Lane between its junction with Brighton Road (A23) and a point below the north west limit of the railway over-bridge on the eastern kerbline.

**57.** Melrose Avenue between its junction with London Road (A23) and a point 1m north east of the north eastern rear wall of 1166 London Road.

**58.** Miller Road between its junction with Purley Way (A23) and a point 10m west of the common boundary between 55 and 53 Miller Road.

**59.** Mill Lane between its junction with Purley Way (A23) and a point opposite the south eastern flank wall of 1 Mill Lane.

**60.** Mitcham Road—

(a) (north west arm) between its junction with Thornton Road (A23) and a point 29m north west of the party wall between 4 and 5 Beddington Terrace, Mitcham Road;

(a) (south east arm)

(i) (north east side) between its junction with Purley Way (A23) and a point 11.5m north west of the north western flank wall of 330 Mitcham Road;

(ii) (south west side) between its junction with Purley Way (A23) and a point 26.5m south east of the south eastern rear wall of 1/2 Purley Way Crescent.

**61.** Norbury Avenue between its junction with London Road (A23) and a point 2.5m south east of the north western flank wall of 328 Norbury Avenue.

**62.** Norbury Court Road—

(a) (north west side) between its junction with London Road (A23) and a point opposite the north eastern boundary of 2 Norbury Court Road;

(b) (south east side) between its junction with London Road (A23) and a point 27.5m south west of the north eastern flank wall of the Fire Station, London Road.

**63.** Norbury Crescent between its junction with London Road (A23) and a point opposite the party wall between 1 and 1a Norbury Crescent.

(a) (north west side) between its junction with London Road (A23) and a point opposite the north eastern flank wall of 1 Northborough Road;

- 77.** Russell Hill Road between its junction with Purley Way (A23) and a point opposite the northern boundary of 21 Russell Hill Road.
- 78.** St. Helens Road between its junction with London Road (A23) and a point 13m north east of the north eastern rear wall of 1374 London Road.
- 79.** Semley Road between its junction with London Road (A23) and a point 4.5m north east of the north eastern boundary of 2 Semley Road.

- (a) (north side) between its junction with Thornton Road (A23) and a point 9.5m west of the eastern flank wall of 164 Thornton Road;

- 81.** Silverleigh Road between its junction with Thornton Road (A23) and a point 17.5m north west of the south eastern flank wall of Thornton Road.

- 85. Stanford Road** between its junction with London Road (A23) and a point 16m west of the western rear wall of 1433 London Road.

  - (b) (south west side) between its junction with Brighton Road (A23) and a point level with the eastern flank wall of 1 and 2 Avenue Court.
- 91. The Drive** between its junction with Brighton Road (A23) and a point 9m south east of the north western rear wall of 2 Brighton Road.
- 92. Thornton Avenue** between its junction with Thornton Road (A23) and a point 4m east of the western rear boundary of 248 Thornton Road.
- 93. Thornton Row** between its junction with London Road (A23) and a point 5m south west of the north eastern rear boundary of 772 London Road.
- 94. Trafalgar Way** between its junction with Purley Way (A23) and a point 17m north east of the north eastern kerbline of Purley Way (measured on the south west side of Trafalgar Way).
- 95. Trojan Way** between its junction with Purley Way (A23) and a point 7m south west of the north eastern flank wall of 294 Purley Way.
- 96. Tylecroft Road—**
- (a) (north west side) between its junction with London Road (A23) and a point opposite the north eastern flank wall of 1 Tylecroft Road;
  - (b) (south east side) between its junction with London Road (A23) and a point opposite the eastern flank wall of 4 Tylecroft Road.
- 97. Victoria Road** between its junction with Brighton Road (A23) and a point 3.75m north west of the north western flank wall of 1 Victoria Road.
- 98. Waddon Court Road (north arm)—**
- (a) (north side) between its junction with Purley Way (A23) and a point opposite a point 16m east of the party wall between 1 and 3 Waddon Court Road;
  - (b) (south side) between its junction with Purley Way (A23) and a point 14.5m east of the party wall between 1 and 3 Waddon Court Road.

**110.** Altyre Road between its junction with Fairfield Road (A232) and a point 26m south of the southern kerbline of the western access to the Croydon Park Hotel.

**111.** Ashburton Road between its junction with Addiscombe Road (A232) and a point 3m south of the southern flank wall of 1 to 10 Walcot Court, Addiscombe Road.

**112.** Barmouth Road between its junction with Wickham Road (A232) and a point 3.5m north west of the party wall between 1 and 3 Barmouth Road.

**116.** Chatsworth Road between its junction with Barclay Road (A232) and a point 10m north of the party wall between 55 and 57 Chatsworth Road.

**117.** Chepstow Rise between its junction with Chepstow Road and a point opposite the southern kerbline of the service road adjacent to 1 to 27 Fleetwood Close.

**118.** Cherry Hill Gardens between its junction with Croydon Road (A232) and a point 20.5m north west of the north western flank wall of 2 Cherry Hill Gardens.

**119.** Cheston Avenue between its junction with Wickham Road (A232) and a point level with the southern wall of 377 Wickham Road.

**120.** Cheyne Walk between its junction with Addiscombe Road (A232) and a point 8m south west of the party wall between 1 and 3 Cheyne Walk.

**121.** Clyde Road between its junction with Addiscombe Road (A232) and a point 6m south of the southern boundary of 1 and 3 Clyde Road.

**122.** Duppas Hill Lane between its junction with The Croydon Flyover (A232) and a point 3m west of the flank wall of 1 (“Fourways”) Duppas Hill Terrace.

**123.** Duppas Road between its junction with Duppas Hill Road (A232) and a point 7m north west of the northern kerbline of Duppas Hill Road.

**124.** Edridge Road—

(a) (west arm) between its junction with The Croydon Flyover (A232) and a point 4m west of the eastern flank wall of Impact House;

(b) (south arm) between its junction with The Croydon Flyover (A232) and a point 11m north of the southern flank wall of 1 Edridge Road.

**125.** Eldon Avenue between its junction with Shirley Road (A232) and a point 61.5m south west of the boundary between 2 Eldon Avenue and Shirley Methodist Church.

**126.** Elgin Road between its junction with Addiscombe Road (A232) and a point 2m north of the southern flank wall of 35 Beverley Hurst, Addiscombe Road.

**127.** Epsom Road between its junction with Duppas Hill Road (A232) and a point 14m south west of the south western flank wall of 118 to 120 Epsom Road.

**128.** Fairfield Path between its junction with Fairfield Road (A232) and a point 32m south east of the south-eastern kerbline of Fairfield Road measured along the south western kerbline of Fairfield Path.

**129.** Fell Road—

(a) (eastbound arm) between its junction with The Croydon Flyover (A232) and a point 2m west of the flank wall of the Municipal Offices;

(b) (northern arm) between its junction with the eastbound arm of Fell Road and The Croydon Flyover (A232) and a point opposite the southern flank wall of the Municipal Offices.

**130.** Fernleigh Close between its junction with Stafford Road (A232) and a point 2.5m south east of the north western flank wall of 1 Fernleigh Close.

**131.** Fryston Avenue between its junction with Addiscombe Road (A232) and a point 10m south west of the boundary between 1 and 3 Fryston Avenue.

**132.** Green Court Gardens between its junction with Addiscombe Road (A232) and a point 2.5m south of the southern boundary of 1 Green Court Gardens.

**133.** Hartland Way between its junction with Wickham Road (A232) and a point 3m south west of the boundary between 1 Hartland Way and 1 Devonshire Road.

**134.** Havelock Road between its junction with Addiscombe Road (A232) and a point opposite the southern flank wall of 203 Addiscombe Road.

**135.** Inwood Close between its junction with Wickham Road (A232) and a point 52m north west of the boundary between 2 and 4 Inwood Close.

**136.** Lake Road between its junction with Wickham Road (A232) and a point level with the southern wall of 516 Wickham Road.

**137.** Langland Gardens between Wickham Road (A232) and a point opposite the northern wall of 496 Langland Gardens.

**138.** Lynwood Gardens between its junction with Croydon Road (A232) and a point 29m north west of the party wall between 1 and 3 Lynwood Gardens.

**139.** Mapledale Avenue between its junction with Addiscombe Road (A232) and a point 29m north east of the boundary between 1 and 3 Mapledale Avenue.

**140.** Mead Way between its junction with Wickham Road (A232) and a point 46m north west of the party wall between 1 and 3 Mead Way.

**141.** Monks Orchard Road—

- (a) (one way section) between Wickham Road (A232) and Monks Orchard Road (two way section);
- (b) (two way section) between Wickham Road (A232) and a point 14m north east of the northern property boundary of West Wickham and Shirley Baptist Church and a point opposite.

**142.** Northampton Road between its junction with Addiscombe Road (A232) and a point 48m south west of the common boundary between 1 and 3 Northampton Road.

**143.** Nursery Avenue between its junction with Wickham Road (A232) and a point opposite the boundary between Gilon and St Winifred, Nursery Avenue.

**144.** Oak Avenue between its junction with Wickham Road (A232) and a point 11m north of the north boundary of 1 Oak Avenue.

**145.** Orchard Avenue between its junction with Wickham Road (A232) and a point 3.5m south west of the boundary between 17 and 19 Orchard Avenue.

**146.** Outram Road between its junction with Addiscombe Road (A232) and a point 29m south of the southern boundary of 6 Outram Road.

**147.** Park Hill Rise—

- (a) (north west arm) between its junction with Chepstow Road (A232) and a point 16m north west of the northern kerbline of Chepstow Road;
- (b) (south east arm) between its junction with Chepstow Road (A232) and a point 17m south east of the southern kerbline of Chepstow Road.

**148.** Park Lane—

- (a) (south arm) between its junction with The Croydon Flyover (A232) and a point opposite the boundary between 68 and 70 Park Lane;
- (b) (north arm) between its junction with Barclay Road (A232) and a point level with the southern kerbline of Katherine Street.

**149.** Phillip Gardens between its junction with Wickham Road (A232) and a point level with the northern wall of 460 Wickham Road.

**150.** Pump Pail North between its junction with The Croydon Flyover (A232) and a point 11m west of the party wall between 10 and 12 Whitgift Street.

**151.** Pump Pail South between its junction with The Croydon Flyover (A232) and a point 28.5m east of the western flank wall of the multi-storey car park.

**152.** Radcliffe Road between its junction with Chepstow Road (A232) and a point 46m north west of the north western flank wall of 10 to 15 Bishopscourt, Radcliffe Road.

**153.** Ridgemount Avenue between its junction with Wickham Road (A232) and a point opposite the north western rear boundary of 189 Wickham Road.

**154.** The Ridgeway between its junction with Croydon Road (A232) and a point opposite the northern boundary of 60 Croydon Road.

**155.** Sandilands between its junction with Addiscombe Road (A232) and a point 45m north of the boundary between 98 and 100 Addiscombe Road.

**156.** Shirley Avenue—

(a) (west arm) between its junction with Shirley Road and a point 5m west of the south western flank of 2 Shirley Avenue;

(b) (south arm) between its junction with Wickham Road (A232) and a point 12m south of the boundary between 161 and 163 Shirley Avenue.

**157.** Shirley Oaks Road (north east side) between its junction with Wickham Road (A232) and a point 10m south of the northern boundary of 121 Wickham Road.

**158.** Shirley Road between its junction with Addiscombe Road (A232) and a point opposite the common boundary between 147 and 149 Shirley Road.

**159.** Spring Park Road between its junction with Wickham Road (A232) and a point opposite the northern boundary of 48 Spring Park Road.

**160.** Unnamed slip road between its junction with Davenant Road and its junction with The Croydon Flyover (A232).

**161.** Upfield between its junction with Addiscombe Road (A232) and a point 6.5m south east of the boundary between 2 and 2a Upfield.

**162.** Upper Shirley Road between its junction with Shirley Road (A232) and a point 4m north of the common boundary between 6 and 8 Upper Shirley Road.

**163.** Valley Walk between its junction with Shirley Road (A232) and a point opposite the south western flank wall of 195 Shirley Road.

**164.** Verdayne Avenue between its junction with Wickham Road (A232) and a point 10.5m south east of the party wall between 3 and 5 Verdayne Avenue.

**165.** Warrington Road between its junction with Duppas Hill Road (A232) and a point 9m north west of the northern kerblines of Duppas Hill Road.

**166.** West Way Gardens between its junction with Wickham Road (A232) and a point 29m south east of the southern kerblines of Wickham Road, measured along the centre line of West Way Gardens.

**167.** Whitethorn Gardens between its junction with Addiscombe Road (A232) and a point 2.5m north of the southern boundary of 1 Whitethorn Gardens.

**168.** Wickham Avenue between its junction with Wickham Road (A232) and a point 1m south east of the party wall between 1a and 3a Wickham Avenue.

**169.** Woodbury Close between its junction with Addiscomben Road (A232) and a point 2m north of the northern flank wall of 1b Woodbury Close.
