EVIDENCE

Rules of evidence etc.

- **27.**—(1) The following enactments, namely—
 - (a) section 99(1) and (3) of the Act(1) (rules of evidence);
 - (b) section 99A(1), (2) and (5) of the Act(2) (proof by written statement);
 - (c) section 12 of the Criminal Justice Act 1967(3) (application of sections 10 and 11 of that Act to courts-martial);
 - (d) section 113(12) of the Police and Criminal Evidence Act 1984(4) (application of Parts VII and VIII of that Act to the armed forces);
 - (e) paragraphs 1 to 6 of Schedule 13 to the Criminal Justice Act 1988(5) (evidence before courts-martial etc.),

shall apply in relation to proceedings before the court as they apply in relation to proceedings before courts-martial under the Act, subject to the modifications referred to in paragraph (2).

- (2) In relation to proceedings before the court—
 - (a) the reference in section 99(1) of the Act to service modifications shall have effect as a reference to the provisions of this Part of these Rules;
 - (b) the reference in section 99A(1) of the Act to service modifications shall have effect as a reference to the modifications to section 9 of the Criminal Justice Act 1967(6) specified in Part I of Schedule 3;
 - (c) the reference in section 12 of the Criminal Justice Act 1967 to such modifications as may be prescribed by the Secretary of State by regulations shall have effect as a reference to the modifications to sections 10 and 11 of that Act specified in Part II of Schedule 3; and
 - (d) the reference in section 113(12) of the Police and Criminal Evidence Act 1984 to modifications which the Secretary of State may by order specify shall have effect as a
