- **2.** To the extent that they are not already in force, the following provisions shall, subject to article 3 below, come into force on 15th January 2001:

 - (c) paragraphs 3, 5(1)(a) and (2), 8, 12, 28, 29, 37, 40(2), 44, 45, 48, 49, 52(2), 63 to 67, 93 and 125(a), 126, 128 and 129 of Schedule 8 to the 1998 Act(3);
 - (d) in Schedule 10, the entry relating to sections 125 and 126 of the Magistrates' Courts Act 1980(4).
