**CRIMINAL LAW, ENGLAND AND WALES**

**The Criminal Justice and Court Services Act  
2000 (Commencement No. 10) Order 2002**

*Made* - - - - *18th July 2002*

The Secretary of State, in exercise of the powers conferred upon him by section 80 of the Criminal Justice and Court Services Act 2000<sup>(1)</sup>, hereby makes the following Order:

**1.** This Order may be cited as the Criminal Justice and Court Services Act 2000 (Commencement No. 10) Order 2002.

**2.** Section 57 of the Criminal Justice and Court Services Act 2000<sup>(2)</sup> (testing persons in police detention) shall come into force on 2nd September 2002 within the following police areas<sup>(3)</sup>:

- (i) Avon and Somerset;
- (ii) Greater Manchester;
- (iii) Thames Valley; and
- (iv) West Yorkshire.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order applies to England and Wales. It brings into force section 57 of the Criminal Justice and Court Services Act 2000 (drug testing persons in police detention) within certain police areas. The provision has already been commenced in the police areas of Nottinghamshire, Staffordshire and the metropolitan police district by virtue of S.I.2001/2232, and the police areas of Bedfordshire, Devon and Cornwall, Lancashire, Merseyside, South Yorkshire and North Wales by virtue of S.I. 2002/1149.
