The Treasury, with the concurrence of the Secretary of State, in relation to regulation 23(i), and the Secretary of State in relation to the remainder of the Regulations, in exercise of the powers conferred upon them by the powers specified in the Schedule to this Instrument, by this Instrument, which contains only regulations made by virtue of or consequential upon sections 1 to 17 of the State Pension Credit Act 2002 ^{M1} and which is made before the end of the period of 6 months beginning with the coming into force of those provisions ^{M2}, hereby make the following Regulations:

PART I
GENERAL

Citation, commencement and interpretation

1.—(1) These Regulations may be cited as the State Pension Credit (Consequential, Transitional and Miscellaneous Provisions) Regulations 2002.

(2) These Regulations shall come into force—

- (a) for the purposes of this Part and Parts II, III and VII on 7th April 2003;
- (b) for all other purposes on 6th October 2003.

(3) In these Regulations—

- “the Act” means the State Pension Credit Act 2002 ^{M3};
- “the Administration Act” means the Social Security Administration Act 1992 ^{M4};
- “the 1998 Act” means the Social Security Act 1998 ^{M5};
- “the Claims and Payments Regulations” means the Social Security (Claims and Payments) Regulations 1987 ^{M6};
- “the Decisions and Appeals Regulations” means the Social Security and Child Support (Decisions and Appeals) Regulations 1999 ^{M7};
- “the appointed day” means the day appointed under section 13(3) of the Act;
- “the State Pension Credit Regulations” means the State Pension Credit Regulations 2002 ^{M8}.

PART II

AMENDMENTS TO THE CLAIMS AND PAYMENTS REGULATIONS

Interpretation of Part II

2. The Claims and Payments Regulations shall be amended in accordance with the following provisions of this Part; and in this Part, unless the context otherwise requires, any reference to a regulation or a Schedule is to the regulation or Schedule bearing that number in the Claims and Payments Regulations.

Amendment of regulation 2

3. In regulation 2—

- (a) in paragraph (1)—
- (i) immediately before the definition of “appropriate office” insert—
““the 2002 Act” means the State Pension Credit Act 2002;
“advance period” means the period specified in regulation 4E(2);”;
- (ii) immediately before the definition of “instrument for benefit payment” insert—
““guarantee credit” is to be construed in accordance with sections 1 and 2 of the 2002 Act;”;
- (iii) after the definition of “personal pension scheme”^{M9} insert—
““qualifying age” has the same meaning as in the 2002 Act by virtue of section 1(6) of that Act;”;
- (iv) after the definition of “retirement annuity contract”^{M10}, insert—

““state pension credit” means state pension credit under the 2002 Act;

“State Pension Credit Regulations” means the State Pension Credit Regulations 2002^{M11}.”

(b) in paragraph (2), in sub-paragraph (b), after the words “income support”, insert “, state pension credit”;

(c) after paragraph (3), insert—

“(4) In these Regulations, references to “beneficiary” include any person entitled to state pension credit.”.

Claims for state pension credit

4.—(1) In regulation 4 (making a claim for benefit), at the end, insert—

“(10) This regulation shall not apply to a claim for state pension credit.”.

(2) In regulation 4B^{M12} (forwarding claims and information), in paragraph (1), in sub-paragraph (b), after the word “applies” insert “ or for state pension credit ”.

(3) After regulation 4C, insert—

“ Making a claim for state pension credit

4D.—(1) A claim for state pension credit need only be made in writing if the Secretary of State so directs in any particular case.

(2) A claim is made in writing either—

(a) by completing and returning in accordance with the instructions printed on it a form approved or provided by the Secretary of State for the purpose; or

(b) in such other written form as the Secretary of State accepts as sufficient in the circumstances of the case.

(3) A claim for state pension credit may be made in writing whether or not a direction is issued under paragraph (1) and may also be made by telephone to, or in person at, an appropriate office or other office designated by the Secretary of State for accepting claims for state pension credit.

(4) A claim made in writing may also be made at the offices of—

(a) a local authority administering housing benefit or council tax benefit;

(b) a person providing services to such an authority; or

(c) a person authorised to exercise any function of a local authority relating to housing benefit or council tax benefit.

(5) Any claim made in accordance with paragraph (4), together with any information and evidence supplied in connection with making the claim, shall be forwarded as soon as reasonably practicable to the Secretary of State by the person who received the claim.

(6) A claim for state pension credit made in person or by telephone is not a valid claim unless a written statement of the claimant's circumstances, provided for the purpose by the Secretary of State, is approved by the person making the claim.

(7) A married or unmarried couple may agree between them as to which partner is to make a claim for state pension credit, but in the absence of an agreement, the Secretary of State shall decide which of them is to make the claim.

(8) Where one member of a married or unmarried couple ("the former claimant") is entitled to state pension credit under an award but a claim for state pension credit is made by the other member of the couple, then, if both members of the couple confirm in writing that they wish the claimant to be the other member, the former claimant's entitlement shall terminate on the last day of the benefit week specified in paragraph (9).

(9) That benefit week is the benefit week of the former claimant which includes the day immediately preceding the day the partner's claim is actually made or, if earlier, is treated as made.

(10) If a claim for state pension credit is defective when first received, the Secretary of State is to provide the person making it with an opportunity to correct the defect.

(11) If that person corrects the defect so that the claim then satisfies the requirements of paragraph (2) and does so within 1 month of the date the Secretary of State last drew attention to the defect, the claim shall be treated as having been properly made on the date—

- (a) the defective claim was first received by the Secretary of State or the person acting on his behalf; or
- (b) if regulation 4F(3) applies, the person informed an appropriate office of his intention to claim state pension credit.

(12) Paragraph (11) does not apply in a case to which regulation 4E(3) applies.

(13) State pension credit is a relevant benefit for the purposes of section 7A of the Social Security Administration Act 1992 ^{M13}.

Making a claim before attaining the qualifying age

4E.—(1) A claim for state pension credit may be made, and any claim made may be determined, at any time within the advance period.

(2) The advance period begins on the date which falls 4 months before the day on which the claimant attains the qualifying age and ends on the day before he attains that age.

(3) A person who makes a claim within the advance period which is defective may correct the defect at any time before the end of the advance period.

Making a claim after attaining the qualifying age: date of claim

4F.—(1) This regulation applies in the case of a person who claims state pension credit on or after attaining the qualifying age.

(2) The date on which a claim is made shall, subject to paragraph (3), be—

- (a) where the claim is made in writing and is not defective, the date on which the claim is first received—

- (i) by the Secretary of State or the person acting on his behalf; or
 - (ii) in a case to which regulation 4D(4) relates, in the office of a person specified therein;
 - (b) where the claim is not made in writing but is otherwise made in accordance with regulation 4D(3) and is not defective, the date the claimant provides details of his circumstances by telephone to, or in person at, the appropriate office or other office designated by the Secretary of State to accept claims for state pension credit; or
 - (c) where a claim is initially defective but the defect is corrected under regulation 4D(11), the date the claim is treated as having been made under that regulation.
- (3) If a claimant—
- (a) informs an appropriate office of his intention to claim state pension credit; and
 - (b) subsequently makes the claim in accordance with regulation 4D within 1 month of complying with sub-paragraph (a), or within such longer period as the Secretary of State may allow,

the claim may, where in the circumstances of the particular case it is appropriate to do so, be treated as made on the day the claimant first informed the appropriate office of his intention to claim the credit.”.

5. In regulation 7 (evidence and information)—

(a) after paragraph (1), insert—

“(1A) A claimant shall furnish such information and evidence as the Secretary of State may require as to the likelihood of future changes in his circumstances which is needed to determine—

- (a) whether a period should be specified as an assessed income period under section 6 of the 2002 Act in relation to any decision; and
- (b) if so, the length of the period to be so specified.

(1B) The information and evidence required under paragraph (1A) shall be furnished within 1 month of the Secretary of State notifying the claimant of the requirement, or within such longer period as the Secretary of State considers reasonable in the claimant’s case.

(1C) In the case of a claimant making a claim for state pension credit in the advance period, time begins to run for the purposes of paragraphs (1) and (1B) on the day following the end of that period.”;

- (b) in paragraph (4) ^{M14}, for the words “or jobseeker’s allowance”, substitute “ jobseeker’s allowance or state pension credit ”.

Advance claims and awards of state pension credit

6.—(1) In regulation 13 (advance claims and awards), in paragraph (3) ^{M15}, after the words “disabled person’s tax credit”^{M16} insert “ state pension credit ”.

(2) After regulation 13C ^{M17} (further claim for and award of disability living allowance), insert—

“ Advance claims for and awards of state pension credit

13D.—(1) Paragraph (2) applies if—

- (a) a person does not satisfy the requirements for entitlement to state pension credit on the date on which the claim is made; and
- (b) the Secretary of State is of the opinion that unless there is a change of circumstances he will satisfy those requirements—
 - (i) where the claim is made in the advance period, when he attains the qualifying age; or
 - (ii) in any other case, within 4 months of the date on which the claim is made.

(2) Where this paragraph applies, the Secretary of State may—

- (a) treat the claim as made for a period beginning on the day (“the relevant day”) the claimant—
 - (i) attains the qualifying age, where the claim is made in the advance period; or
 - (ii) is likely to satisfy the requirements for entitlement in any other case; and
- (b) if appropriate, award state pension credit accordingly, subject to the condition that the person satisfies the requirements for entitlement on the relevant day.

(3) An award under paragraph (2) may be revised under section 9 of the Social Security Act 1998 ^{M18} if the claimant fails to satisfy the conditions for entitlement to state pension credit on the relevant day.”.

Payability of state pension credit

7.—(1) In regulation 16 (date of entitlement under an award), in paragraph (4) after the words “income support”, insert “ , state pension credit ”.

(2) After regulation 16, insert—

**“ Date of entitlement under an award of state pension credit for the purpose of
payability and effective date of change of rate**

16A.—(1) For the purpose only of determining the day from which state pension credit is to become payable, where the credit is awarded from a day which is not the first day of the claimant’s benefit week, entitlement shall begin on the first day of the benefit week next following.

(2) In the case of a claimant who—

- (a) immediately before attaining the qualifying age was entitled to income support or income-based jobseeker’s allowance and is awarded state pension credit from the day on which he attains the qualifying age; or
- (b) was entitled to an income-based jobseeker’s allowance after attaining the qualifying age and is awarded state pension credit from the day which falls after the date that entitlement ends,

entitlement to the guarantee credit shall, notwithstanding paragraph (1), begin on the first day of the award.

(3) Where a change in the rate of state pension credit would otherwise take effect on a day which is not the first day of the claimant’s benefit week, the change shall take effect from the first day of the benefit week next following.

(4) For the purpose of this regulation, “benefit week” means the period of 7 days beginning on the day on which, in the claimant’s case, state pension credit is payable in accordance with regulation 26B.”.

Payment

9. After regulation 26A ^{M21} (jobseeker’s allowance), insert—

“ State pension credit

26B.—(1) Except where paragraph (2) applies, state pension credit shall be payable on Mondays, but subject, where state pension credit is payable in accordance with paragraph (3) (a), to the provisions of regulation 21 (direct credit transfer).

(2) State pension credit shall be payable—

- (a) if retirement pension is payable to the claimant, on the same day as the retirement pension is payable; or

- (b) on such other day of the week as the Secretary of State may, in the particular circumstances of the case, determine.
- (3) Payment of state pension credit shall be made either—
 - (a) in accordance with regulation 21 (direct credit transfer); or
 - (b) by means of an instrument of payment or an instrument for benefit payment at such place as the Secretary of State, after enquiry of the claimant, may from time to time specify.
- (4) State pension credit paid in accordance with paragraph (3)(b) shall be paid weekly in advance.
- (5) Where the amount of state pension credit payable is less than £1.00 per week, the Secretary of State may direct that it shall be paid at such intervals, not exceeding 13 weeks, as may be specified in the direction.
- (6) Where state pension credit is—
 - (a) paid by means of a book of serial orders; and
 - (b) increased or reduced by an amount which, when added to any previous such increase, is less than 50 pence per week,
 the Secretary of State may defer payment of that increase or disregard the reduction until either—
 - (i) the termination of entitlement; or, if earlier,
 - (ii) the expiration of one week from the date specified for payment of the last order in that book.
- (7) Where state pension credit is—
 - (a) paid by means of a book of serial orders; and
 - (b) the amount of state pension credit payable to a third party under Schedule 9 is increased so that the amount of the credit payable to the claimant is reduced by an amount which, with any previous reduction, is less than 50 pence per week,
 the Secretary of State may make the payment to the third party and disregard the reduction in the claimant’s state pension credit for the remainder of the period to which the book relates.”.

14.—(1) In Schedule 9 (deductions from benefit and direct payment to third parties)—

- (a) in paragraph 1, in sub-paragraph (1) ^{M26}—
 - (i) in the definition of “family”, at the end, add “ and for the purposes of state pension credit “a family” comprises the claimant, his partner, any additional partner to whom section 12(1)(c) of the 2002 Act applies and any person who has not attained the age of 19, is treated as a child for the purposes of section 142 of the Contributions and Benefits Act and lives with the claimant or the claimant’s partner; ”;
 - (ii) in the definition of “housing costs”, at the end, add—

“(9) Subject to paragraph 8, in the case of state pension credit, a determination under this paragraph shall not be made without the consent of the beneficiary if the aggregate amount calculated in accordance with sub-paragraphs (3), (4), (5) and (6) exceeds a sum equal to 25 per cent. of the appropriate minimum guarantee less any housing costs under Schedule II to the State Pension Credit Regulations which may be applicable in the particular case.”;

(f) in paragraph 8^{M31}, after sub-paragraph (2), insert—

“(2A) In the case of state pension credit, the maximum aggregate amount payable under paragraphs 3(2)(a), 5, 6, and 7 shall not, without the consent of the beneficiary, exceed a sum equal to 25 per cent. of the appropriate minimum guarantee less any housing costs under Schedule II to the State Pension Credit Regulations which may be applicable in the particular case.”.

(2) In Schedule 9A^{M32} (deductions of mortgage interest from benefit and payment to qualifying lenders)—

(a) in paragraph 1, in the definition of “relevant benefits”, at the end of sub-paragraph (c), insert—

“and

(d) state pension credit which is either paid alone or paid together with any retirement pension, incapacity benefit or severe disablement allowance in a combined payment in respect of any period;”;

(b) in paragraph 2 for the words from the beginning of sub-paragraph (a) to “is determined”, substitute—

“the amount to be met under—

- (i) Schedule 3 to the Income Support Regulations; or
- (ii) Schedule 2 to the Jobseeker’s Allowance Regulations; or
- (iii) Schedule II to the State Pension Credit Regulations;”;

(c) in paragraph 3—

(i) after sub-paragraph (1), insert—

“(1A) Subject to the following provisions of this paragraph, the part of state pension credit which, as determined by the Secretary of State in accordance with regulation 34A, shall be paid directly to the qualifying lender, is a sum equal to the amount of mortgage interest to be met under paragraph 7 of Schedule II to the State Pension Credit Regulations.”;

(ii) in sub-paragraph (3)—

(aa) after the words “or income-based jobseeker’s allowance” insert “ or a relevant beneficiary’s appropriate minimum guarantee in state pension credit ” and for the words “sub-paragraph (1)” substitute “ sub-paragraph (1) or (1A) ” ;

(bb) in head (b), after the words “as the case may be” insert “ paragraph 5(9) or (12) or paragraph 14 of Schedule II to the State Pension Credit Regulations or ” ;

(cc) in the value “A”, after the words “as the case may be” insert “ paragraph 1 of Schedule II to the State Pension Credit Regulations or ” ;

(dd) in the value “B”, after the words “as the case may be” insert “ paragraph 7 of Schedule II to the State Pension Credit Regulations or ” ;

- (ee) in the value “C”, after the words “as the case may be” insert “ paragraph 5(9) or (12) or paragraph 14 of Schedule II to the State Pension Credit Regulations or ”;
- (iii) in sub-paragraph (4), at the beginning, insert “ Except where the relevant benefit is state pension credit, ”;
- (iv) after sub-paragraph (9), add—
- “(10) In sub-paragraph (1), the relevant benefits do not include in the case of state pension credit so much of any additional amount which is applicable in the claimant’s case under Schedule II to the State Pension Credit Regulations (housing costs) in respect of a period before the decision awarding state pension credit was made.”;
- (d) in paragraph 4, in sub-paragraph (2)(a)^{M33}, after the words “as the case may be” insert “ paragraph 9 of Schedule II to the State Pension Credit Regulations or ”;
- (e) in paragraph 10—
- (i) for sub-paragraph (2), substitute—
- “(2) Subject to sub-paragraph (4), the information referred to in heads (a), (b), (c) and (d) of sub-paragraph (1) shall be provided at the request of the Secretary of State when a claim for—
- (a) income support or income-based jobseeker’s allowance is made and a sum in respect of mortgage interest is to be brought into account in determining the applicable amount; or
- (b) state pension credit is made and a sum in respect of housing costs is applicable in the claimant’s case in accordance with regulation 6(6)(c) of the State Pension Credit Regulations.”;
- (ii) in sub-paragraph (3), in head (a), after the words “income support” insert “ , state pension credit ”.

“(1) is a relevant decision for the purposes of section 6 of the State Pension Credit Act and—

 - (i) on making that decision, the Secretary of State specified a period as the assessed income period; and
 - (ii) that period has ended or is about to end.”;

“(8) In relation to the assessed income period, the only change of circumstance relevant for the purposes of paragraph (2)(a) is that the assessed income period ends in accordance with section 9(4) of the State Pension Credit Act or the regulations made under section 9(5) of that Act.”.

- he shall make the determination on the assumption that the relevant evidence or information which is not in his possession is adverse to the claimant.”.

1. Where the amount of state pension credit payable under an award is changed by a superseding decision made on the ground that there has been a relevant change of circumstances, that superseding decision shall take effect from the following days—

- (a) for the purpose only of determining the day on which an assessed income period begins under section 9 of the State Pension Credit Act, from the day following the day on which the last previous assessed income period ended; and
- (b) except as provided in the following paragraphs, from the day that change occurs or is expected to occur if either of those days is the first day of a benefit week but if it is not from the next following such day.

2. Subject to paragraph 3, where the relevant change is that the claimant’s income (other than deemed income from capital) has changed, the superseding decision shall take effect on the first day of the benefit week in which that change occurs or if that is not practicable in the circumstances of the case, on the first day of the next following benefit week.

3. Paragraph 2 shall not apply where the only relevant change is that working tax credit under the Tax Credits Act 2002 ^{M43} becomes payable or becomes payable at a higher rate.

4. A superseding decision shall take effect from the day the change of circumstances occurs or is expected to occur if—

- (a) the person ceases to be or becomes a prisoner, and for this purpose “prisoner” has the same meaning as in regulation 1(2) of the State Pension Credit Regulations; or
- (b) whilst entitled to state pension credit a claimant is awarded another social security benefit and in consequence of that award his benefit week changes or is expected to change.

5. In a case where the relevant change of circumstances is that the claimant ceased for one or more days to be a patient, the superseding decision shall take effect from the first day of the benefit week in which the change occurred.

6. In paragraph 5, “patient” means a person (other than a prisoner) who is regarded as receiving free in-patient treatment within the meaning of the Social Security (Hospital In-Patients) Regulations 1975 ^{M44}.

PART IV

 - “(ii) “dwelling occupied as the home” means the dwelling together with any garage, garden and outbuildings, normally occupied by the claimant as his home including any premises not so occupied which it is impracticable or unreasonable to sell separately, in particular, in Scotland, any croft land on which the dwelling is situated.”;
- (b) regulation 4 (persons receiving treatment outside Great Britain) shall be renumbered paragraph (1) of regulation 4 and after the renumbered paragraph (1) there shall be added—
 - “(2) Paragraph (1) applies only where—
 - (a) the “person” is the claimant or his partner; and
 - (b) the claimant satisfied the conditions for entitlement to state pension credit immediately before he or, as the case may be, his partner, left Great Britain.”;
- (c) in regulation 5 (persons treated as being or not being members of the same household), in paragraph (1), after sub-paragraph (d) add—
 - “(e) either he or the claimant is not in Great Britain and is not treated as being in Great Britain in accordance with regulation 4;
 - (f) he is not in Great Britain and none of the circumstances specified in either paragraph (2) or (3) of regulation 3 would, had he been the claimant, apply in his case”;
- (d) in regulation 7 (savings credit), after paragraph (3), add—
 - “(4) If a calculation made for the purposes of paragraph (1)(b) or (c) results in a fraction of a penny, that fraction shall, if it would be to the claimant’s advantage, be treated as a penny; otherwise it shall be disregarded.”;
- (e) in regulation 10 (assessed income period), in paragraph (7), in sub-paragraph (a), for the word “following” substitute “ on or after ”;
- (f) after regulation 13 (small amounts of state pension credit), insert—

“ Part-weeks

13A.—(1) The guarantee credit shall be payable for a period of less than a week (“a part-week”) at the rate specified in paragraph (3) if—

- (a) the claimant was entitled to income support or an income-based jobseeker’s allowance immediately before the first day on which the conditions for entitlement to the credit are satisfied; and
- (b) the claimant’s entitlement to the credit is likely to continue throughout the first full benefit week which follows the part-week.

(2) For the purpose of determining the amount of the guarantee credit payable in respect of the part-week, no regard shall be had to any income of the claimant and his partner.

(3) The amount of the guarantee credit payable in respect of the part-week shall be determined—

- (a) by dividing by 7 the weekly amount of the guarantee credit which, taking into account the requirements of paragraph (2), would be payable in respect of a full week; and then
- (b) multiplying the resulting figure by the number of days in the part-week,

any fraction of a penny being rounded up to the nearest penny.

Date on which benefits are treated as paid

13B.—(1) The following benefits shall be treated as paid on the day of the week in respect of which the benefit is payable—

- (a) severe disablement allowance;
- (b) short-term and long-term incapacity benefit;
- (c) maternity allowance;
- (d) contribution-based jobseeker’s allowance within the meaning of section 1(4) of the Jobseekers Act 1995 ^{M46}.

(2) All benefits except those mentioned in paragraph (1) shall be treated as paid on the first day of the benefit week in respect of which the benefit is payable.”;

(g) in regulation 15 (income for the purposes of the Act), in paragraph (1) for sub-paragraph (l), substitute—

- “(l) housing benefit;
- (m) council tax benefit;
- (n) bereavement payment ^{M47};
- (o) statutory sick pay;
- (p) statutory maternity pay;
- (q) statutory paternity pay payable under Part 12ZA of the 1992 Act ^{M48};
- (r) statutory adoption pay payable under Part 12ZB of the 1992 Act ^{M49};
- (s) any benefit similar to those mentioned in the preceding provisions of this paragraph payable under legislation having effect in Northern Ireland.”;

(h) in regulation 17 (calculation of weekly income)—

(i) in paragraph (5) omit the word “and” at the end of sub-paragraph (a) and at the end of sub-paragraph (b), add—

- “and
- (c) any payment which is made on an occasional basis.”;

(ii) for paragraph (9), substitute—

“(9) The sums specified in Schedule VI shall be disregarded in calculating—

- (a) the claimant’s earnings; and
- (b) any amount to which paragraph (5) applies if the claimant or his partner is the first owner of the copyright, patent or trade mark or the author of the book registered under the Public Lending Right Scheme 1982 ^{M50}.

(9A) For the purposes of paragraph (9)(b), and for that purpose only, the amounts specified in paragraph (5) shall be treated as though they were earnings.”;

(iii) in paragraph (10), at the beginning, insert “Subject to regulation 17C (deduction of tax and contributions for self-employed earners),”;

(iv) after paragraph (10), add—

“(11) In the case of the earnings of self-employed earners, the amounts specified in paragraph (10) shall be taken into account in accordance with paragraph (4) or,

as the case may be, paragraph (10) of regulation 13 of the Computation of Earnings Regulations, as having effect in the case of state pension credit.”;

(i) after regulation 17, insert—

“ Earnings of an employed earner

17A.—(1) For the purposes of state pension credit, the provisions of this regulation which relate to the earnings of employed earners, shall have effect in place of those prescribed for such earners in the Computation of Earnings Regulations.

(2) Subject to paragraphs (3) and (4), “earnings” in the case of employment as an employed earner, means any remuneration or profit derived from that employment and includes—

- (a) any bonus or commission;
 - (b) any payment in lieu of remuneration except any periodic sum paid to a claimant on account of the termination of his employment by reason of redundancy;
 - (c) any payment in lieu of notice;
 - (d) any holiday pay;
 - (e) any payment by way of a retainer;
 - (f) any payment made by the claimant’s employer in respect of expenses not wholly, exclusively and necessarily incurred in the performance of the duties of the employment, including any payment made by the claimant’s employer in respect of—
 - (i) travelling expenses incurred by the claimant between his home and place of employment;
 - (ii) expenses incurred by the claimant under arrangements made for the care of a member of his family owing to the claimant’s absence from home;
 - (g) the amount of any payment by way of a non-cash voucher which has been taken into account in the computation of a person’s earnings in accordance with Part V of Schedule 3 to the Social Security (Contributions) Regulations 2001^{M51};
 - (h) statutory sick pay and statutory maternity pay payable by the employer under the 1992 Act;
 - (i) statutory paternity pay payable under Part 12ZA of the 1992 Act;
 - (j) statutory adoption pay payable under Part 12ZB of the 1992 Act;
 - (k) any sums payable under a contract of service—
 - (i) for incapacity for work due to sickness or injury; or
 - (ii) by reason of pregnancy or confinement.
- (3) “Earnings” shall not include—
- (a) subject to paragraph (4), any payment in kind;
 - (b) any payment in respect of expenses wholly, exclusively and necessarily incurred in the performance of the duties of the employment;
 - (c) any occupational pension;

(d) any lump sum payment made under the Iron and Steel Re-adaptation Benefits Scheme ^{M52}.

(4) Paragraph (3)(a) shall not apply in respect of any non-cash voucher referred to in paragraph (2)(g).

(5) In this regulation “employed earner” means a person who is gainfully employed in Great Britain either under a contract of service, or in an office (including elective office) with emoluments chargeable to income tax under Schedule E.

Earnings of self-employed earners

17B.—(1) For the purposes of state pension credit, the provisions of the Computation of Earnings Regulations in their application to the earnings of self-employed earners, shall have effect in so far as provided by this regulation.

(2) In their application to state pension credit, regulations 11 to 14 of the Computation of Earnings Regulations shall have effect as if—

(a) “claimant” referred to a person claiming state pension credit and any partner of the claimant;

(b) “personal pension scheme” referred to a personal pension scheme—

(i) as defined in section 1 of the Pension Schemes Act 1993 ^{M53}; or

(ii) as defined in section 1 of the Pension Schemes (Northern Ireland) Act 1993 ^{M54}.

(3) In regulation 11 (calculation of earnings of self-employed earners), paragraph (1) shall have effect, but as if the words “Except where paragraph (2) applies” were omitted.

(4) In regulation 12 (earnings of self-employed earners)—

(a) paragraph (1) shall have effect;

(b) for paragraph (2), the following provision shall have effect—

(“ Earnings does not include—

(a) where a claimant occupies a dwelling as his home and he provides in that dwelling board and lodging accommodation for which payment is made, those payments;

(b) any payment made by a local authority to a claimant—

(i) with whom a person is accommodated by virtue of arrangements made under section 23(2)(a) of the Children Act 1989 ^{M55} (provision of accommodation and maintenance for a child whom they are looking after) or, as the case may be, section 26(1) of the Children (Scotland) Act 1995 ^{M56}; or

(ii) with whom a local authority foster a child under the Fostering of Children (Scotland) Regulations 1996 ^{M57};

(c) any payment made by a voluntary organisation in accordance with section 59(1)(a) of the Children Act 1989 (provision of accommodation by voluntary organisations);

(d) any payment made to the claimant or his partner for a person (“the person concerned”) who is not normally a member of the claimant’s household but is temporarily in his care, by—

- (i) a health authority;
 - (ii) a local authority;
 - (iii) a voluntary organisation;
 - (iv) the person concerned pursuant to section 26(3A) of the National Assistance Act 1948 ^{M58}; or
 - (v) a primary care trust established under section 16A of the National Health Service Act 1977 ^{M59};
- (e) any sports award.”
- (5) In regulation 13 (calculation of net profit of self-employed earners)—
 - (a) for paragraphs (1) to (3), the following provision shall have effect—
 - “(3) For the purposes of regulation 11 (calculation of earnings of self-employed earners), the earnings of a claimant to be taken into account shall be—
 - (a) in the case of a self-employed earner who is engaged in employment on his own account, the net profit derived from that employment;
 - (b) in the case of a self-employed earner whose employment is carried on in partnership, his share of the net profit derived from that employment less—
 - (i) an amount in respect of income tax and of social security contributions payable under the Contributions and Benefits Act calculated in accordance with regulation 14 (deduction of tax and contributions for self-employed earners); and
 - (ii) one half of any premium paid in the period that is relevant under regulation 11 in respect of a retirement annuity contract or a personal pension scheme.”
 - (b) paragraphs (4) to (12) shall have effect.
 - (6) Regulation 14 (deduction of tax and contributions for self-employed earners) shall have effect.”;
- (j) in regulation 21 (notional capital), after paragraph (2), add—
 - “(3) Where a claimant stands in relation to a company in a position analogous to that of a sole owner or partner in the business of that company, he shall be treated as if he were such sole owner or partner and in such a case—
 - (a) the value of his holding in that company shall, notwithstanding regulation 19 (calculation of capital), be disregarded; and
 - (b) he shall, subject to paragraph (4), be treated as possessing an amount of capital equal to the value or, as the case may be, his share of the value of the capital of that company and the foregoing provisions of this Chapter shall apply for the purposes of calculating that amount as if it were actual capital which he does possess.
 - (4) For so long as a claimant undertakes activities in the course of the business of the company, the amount which he is treated as possessing under paragraph (3) shall be disregarded.
 - (5) Where under this regulation a person is treated as possessing capital, the amount of that capital shall be calculated in accordance with the provisions of this Part as if it were actual capital which he does possess.”;

(k) after regulation 24 (income paid to third parties), insert—

“ Rounding of fractions

24A. Where any calculation under this Part results in a fraction of a penny that fraction shall, if it would be to the claimant’s advantage, be treated as a penny; otherwise it shall be disregarded.”;

(l) in Schedule II (housing costs)—

(i) in paragraph 5, after sub-paragraph (1), insert—

“(1A) In paragraph (1), “housing benefit expenditure” means expenditure in respect of which housing benefit is payable as specified in regulation 10(1) of the Housing Benefit (General) Regulations 1987 ^{M60} but does not include any such expenditure in respect of which an additional amount is applicable under regulation 6(6)(c) (housing costs).”;

(ii) in paragraph 7, for sub-paragraph (5), substitute—

“(5) Where in the period since the amount applicable under this Schedule was last determined, there has been a change of circumstances, other than a reduction in the amount of the outstanding loan, which increases or reduces the amount applicable, it shall be recalculated so as to take account of that change.”;

(iii) in paragraph 13, at the end, add—

“(6) In this paragraph—

- (a) “co-ownership scheme” means a scheme under which a dwelling is let by a housing association and the tenant, or his personal representative, will, under the terms of the tenancy agreement or of the agreement under which he became a member of the association, be entitled, on his ceasing to be a member and subject to any condition stated in either agreement, to a sum calculated by reference directly or indirectly to the value of the dwelling;
- (b) “Crown tenant” means a person who occupies a dwelling under a tenancy or licence where the interest of the landlord belongs to Her Majesty in right of the Crown or to a government department or is held in trust for Her Majesty for the purposes of a government department except (in the case of an interest belonging to Her Majesty in right of the Crown) where the interest is under the management of the Crown Estate Commissioners;
- (c) “housing association” has the meaning assigned to it by section 1(1) of the Housing Associations Act 1985 ^{M61};
- (d) “long tenancy” means a tenancy granted for a term of years certain exceeding twenty one years, whether or not the tenancy is, or may become, terminable before the end of that term by notice given by or to the tenant or by re-entry, forfeiture (or, in Scotland, irritancy) or otherwise and includes a lease for a term fixed by law under a grant with a covenant or obligation for perpetual renewal unless it is a lease by sub-demise from one which is not a long tenancy.”;

(m) in Schedule III—

(i) in paragraph 1—

(aa) in sub-paragraph (2), in the words which apply instead of section 3(1), the words “the claimant” on the second occasion on which they occur shall be omitted;

(bb) in sub-paragraph (8), after “5,” insert “ 6(8), ”;

- (n) in Schedule IV, in paragraph 11—
 - (i) in sub-paragraph (2), omit head (d);
 - (ii) in sub-paragraph (3)(b), after the words “paragraph 1(a) to (f)”, insert “ or paragraph 7 ”;
- (o) in Schedule V, in Part I—
 - (i) after paragraph 9, insert—

“9A. The assets of any business owned in whole or in part by the claimant if—

- (a) he is not engaged as a self-employed earner in that business by reason of some disease or bodily or mental disablement; but
- (b) he intends to become engaged (or, as the case may be, re-engaged) as a self-employed earner in that business as soon as he recovers or is able to become engaged, or re-engaged, in that business,

PART VII

TRANSITIONAL PROVISIONS

Persons entitled to income support immediately before the appointed day

36.—(1) This regulation applies in the case of any person (referred to as “the transferee”) who—

- (a) immediately before the appointed day, is entitled to income support; and
- (b) attains or has attained the qualifying age on or before the appointed day.

(2) The transferee shall be treated as having made a claim for state pension credit in the period of 6 months immediately preceding the appointed day.

(3) The Secretary of State shall, so far as practicable, decide before the appointed day a claim for state pension credit treated as made under paragraph (2).

(4) A decision of the Secretary of State made in accordance with paragraph (3) may be revised by the Secretary of State at any time within the period of 13 months commencing on the date of notification of the decision if an application is made by the claimant to the Secretary of State or a person acting on his behalf for the decision to be revised.

(5) For the purposes of section 9 (duration of assessed income period), the decision of the Secretary of State takes effect on the appointed day.

(6) Notwithstanding the provisions of regulation 26B(4) of the Claims and Payments Regulations ^{M109}, state pension credit may in the case of a transferee be payable in arrears if the income support to which he was entitled before the appointed day was paid in arrears.

(7) [^{F5}Notwithstanding the provisions of Schedule 3B of the Decisions and Appeals Regulations,] in the case of a transferee to whom paragraph (6) applies, any decision under section 10 of the 1998 Act which—

- (a) supersedes a decision awarding state pension credit to a transferee; and
- (b) is made on the ground that there has been a relevant change of circumstances since the decision was made or that it is anticipated that a relevant change of circumstances will occur,

shall take effect from the first day of the benefit week in which the change occurs or is expected to occur.

[^{F6}(7A) Notwithstanding the provisions of paragraph (7), where the relevant change of circumstances is that the transferee becomes a patient ^{M110} again within the same benefit week in which he ceased to be a patient, the superseding decision in respect of becoming a patient again shall take effect from the first day of the benefit week following the benefit week in which the change occurs.]

(8) For the purpose of paragraph (7), “benefit week” means the period of 7 days ending on the day on which, in the claimant’s case, state pension credit is payable.

(9) Any payment made to a transferee to whom paragraph (10) applies—

- (a) in respect of a period falling on or after the appointed day;
- (b) which would have been payable under an award of income support but for the coming into force of the Act,

shall be offset against any state pension credit payable under an award on or after 6th October 2003 on a claim treated as made under paragraph (2).

(10) This paragraph applies to a transferee in respect of whom no decision has been made on his claim for state pension credit which is treated as having been made in accordance with paragraph (2).

(11) If the Secretary of State determines that no state pension credit is payable, or that the amount payable is less than the payments referred to in paragraph (9), he shall determine the amount of the overpayment.

(12) The amount of any overpayment determined in accordance with paragraph (11) shall be recoverable by the Secretary of State by the same procedures and subject to the same conditions as if it were recoverable under section 71 (1) of the Administration Act.

(13) Where the transferee—

- (a) has, immediately before the appointed day, an award of income support payable by direct credit transfer in accordance with regulation 21 of the Claims and Payments Regulations; and
- (b) state pension credit is payable or treated as payable to him as from the appointed day,

the state pension credit shall be paid by direct credit transfer into the same bank or other account as the payment of income support; and for this purpose, any application made or treated as made and any consent given or treated as given in relation to the payment of income support shall be treated as made or given in relation to the payment of state pension credit.

(14) Where—

- (a) the transferee had immediately before the appointed day an award of income support from which deductions were made or where part of the benefit was paid to a third party in accordance with—
 - (i) regulation 34A of, and Schedule 9A to, the Claims and Payments Regulations (mortgage interest payments); or
 - (ii) regulation 35 of, and Schedule 9B to, those Regulations (deductions which may be made and payments to third parties); and
- (b) state pension credit is payable or treated as payable to the transferee as from the appointed day,

then as from the appointed day, those deductions shall be made from the transferee’s state pension credit and those payments of part of the benefit shall continue to be made to the third party in accordance with those provisions.

Assessed income period

37.—(1) A person to whom paragraph (2) applies shall have an assessed income period allotted to him by the Secretary of State of at least 5 years but not exceeding 7 years beginning on the day the decision takes effect, unless regulation 10(1) of the State Pension Credit Regulations applies in his case.

(2) This paragraph applies to the first assessed income period specified in respect of a person who—

- (a) attains or has attained the age of 65 or whose partner attains or has attained that age on or before the appointed day; and
- (b) is awarded state pension credit with effect from the appointed day.

Claims for state pension credit

38.—(1) A claim for state pension credit may be made before the appointed day by a person who is not in receipt of income support at the time the claim is made.

(2) Where the Secretary of State is satisfied that unless there is a change in the claimant’s circumstances before the appointed day he will satisfy the conditions for entitlement to state pension credit on that day, then the Secretary of State may—

- (a) treat that claim as if made for a period beginning with the appointed day; and
- (b) award benefit accordingly, but subject to the condition that the claimant does in fact satisfy those conditions when benefit becomes payable under the award.

(3) A decision under paragraph (2)(b) to award benefit may be revised under section 9 of the 1998 Act if the requirements for entitlement to state pension credit are found not to have been satisfied on the appointed day.

(4) A claim for state pension credit made in the period of 12 months beginning with the appointed day may be treated as made on that day if the claimant satisfied the conditions for entitlement to state pension credit on that day.

(5) A person who does not fall within paragraph (4)—

- (a) solely because he does not satisfy the conditions for entitlement to state pension credit on the appointed day; but
- (b) does satisfy those conditions on a day after the appointed day but before the day on which the claim is received by the Secretary of State,

shall be treated as having made the claim on the day the conditions were first satisfied in his case.

(6) A claim for income support made in the period of 6 months preceding the appointed day may be treated also as a claim for state pension credit if the claimant—

- (a) is not entitled to income support; and

- (b) has attained the age of 60 on the date the claim is made or will have attained that age on the appointed day.
- (7) Paragraphs (2) and (3) shall apply to a claim treated as made under paragraph (6) as they apply to a claim made under paragraph (1).
- (8) In the case of a person who—
 - (a) on the appointed day has attained the qualifying age;
 - (b) was, within the period of 6 months preceding the appointed day, entitled to income support; and
 - (c) was not entitled to income support on the day immediately preceding the appointed day, that person shall be treated as having made a claim for state pension credit for a period beginning on the appointed day.
- (9) The Secretary of State may treat a claim for state pension credit made in accordance with paragraph (1) as also a claim for income support made on the same day.

EXPLANATORY NOTE

(This note is not part of the Regulations)

The Regulations contained in this Instrument are made either by virtue of, or consequential upon, provisions in the State Pension Credit Act 2002 (c. 16) (“the 2002 Act”). This Instrument is made before the expiry of the period of 6 months beginning with the coming into force of those provisions; the regulations in it are therefore exempt in accordance with section 173(5) of the Social Security Administration Act 1992 from the requirement in section 172(1) of that Act to refer proposals to make Regulations to the Social Security Advisory Committee and are made without reference to that Committee.

The amendments in Parts II, III, V and VI are consequential on the introduction of state pension credit. Part VII contains transitional matters.

Part I of the Regulations provides for their citation, commencement and interpretation.

Part II amends the Social Security (Claims and Payments) Regulations 1987 so as to make separate provision for claims for, and payment of, state pension credit. Provision is made (regulation 4) for claims to be made by telephone or in person. Claims may be made at any time in the 4 months preceding the day a claimant attains the qualifying age for entitlement to state pension credit.

Claimants may be required to provide information as to the likelihood of future changes in their circumstances (regulation 5).

Regulation 7 provides for the date on which entitlement to state pension credit is to begin and regulation 9 for the day on which, and the method by which, the credit is to be paid.

Regulations 8, 10 to 12 and 14 apply provisions currently in the Social Security (Claims and Payments) Regulations 1987 to state pension credit. Regulation 13 provides that regulation 35A (transitional provisions relating to persons in hostels and certain residential accommodation) is not to apply to state pension credit.

Part III applies provisions of the Social Security and Child Support (Decisions and Appeals) Regulations 1999 to state pension credit. Regulation 20 further provides that, where a claimant’s appropriate minimum guarantee includes a transitional amount, provisions in section 159B of the Social Security Administration Act 1992 (inserted by the 2002 Act) relating to the effect of alterations affecting state pension credit, are not to apply. Regulation 22 makes provision as to the date from which a decision under section 10 of the Social Security Act 1998 (superseding decision) resulting from a change of circumstances takes effect.

Part IV makes changes to the State Pension Credit Regulations 2002. It adds provisions—

- 0 relating to part-weeks;
- 0 as to the meaning and calculation of “earnings” for the purposes of state pension credit;
- 0 relating to the rounding of fractions;
- 0 as to the disregard of assets of any business owned by the claimant.

Part V adds references to state pension credit to—

- 0 the Social Security (Payments on account, Overpayments and Recovery) Regulations 1988;
- 0 the Social Security (Attendance Allowance) Regulations 1991;
- 0 the Child Support (Arrears, Interest and Adjustment of Maintenance Assessments) Regulations 1992;
- 0 the Child Support (Maintenance Calculations and Special Cases) Regulations 2000;
- 0 the Social Security (Disability Living Allowance) Regulations 1991;
- 0 the Income Support (General) Regulations 1987;
- 0 the Jobseeker’s Allowance Regulations 1996;
- 0 the Social Fund Maternity and Funeral Expenses (General) Regulations 1987;
- 0 the Social Fund Cold Weather Payments (General) Regulations 1988.

It also makes amendments to the Income Support (General) Regulations 1987 consequential upon the 2002 Act which removes from entitlement to income support those who have attained the qualifying age for the purposes of state pension credit.

Part VI adds references to state pension credit to—

- 0 the Fines (Deductions from Income Support) Regulations 1992;
- 0 the Council Tax (Deductions from Income Support) Regulations 1993;
- 0 the Community Charges (Deductions from Income Support)(Scotland) Regulations 1989;
- 0 the Community Charges (Deductions from Income Support)(No. 2) Regulations 1990.

Part VII makes transitional provisions. Regulation 36 provides for those who were entitled to income support immediately before the 2002 Act comes into force to be treated as making a claim for state pension credit and for the determination of that claim. Regulation 37 makes provision for variable assessed income periods. Regulation 38 provides that a person not in receipt of income support may claim state pension credit before provisions of the 2002 Act relating to entitlement are commenced.

The impact on business of applying these Regulations is minimal and the publication of a regulatory impact assessment is therefore not necessary. A summary of the contents of the assessment made for the State Pension Credit Bill was published at paragraphs 183 and 184 of the Explanatory Notes relating to the Bill.
